## A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 328L-3, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 There is established in the state treasury the "(a) emergency and budget reserve fund which shall be a special fund 4 5 administered by the director of finance, into which shall be 6 deposited: 7 (1) [Twenty four and one half per cent of the moneys 8 received from the tobacco settlement moneys under 9 section 328L-2(b)(1);] Moneys received from the tobacco 10 settlement moneys under section 328L-2; 11 Appropriations made by the legislature to the fund; and (2) 12 Five per cent of the state general fund balance at the (3) 13 close of the fiscal year, whenever state general fund 14 revenues for each of two successive fiscal years exceeds 15 revenues for each of the preceding fiscal years by five 16 per cent, pursuant to article VII, section 6 of the **17** Hawaii constitution. For the purpose of this section,

1	the general fund balance at the close of the fiscal year
2	shall be calculated before any tax refund or tax credit
3	is authorized by the legislature, pursuant to article
4	VII, section 6 of the Hawaii constitution, that is
5	provided during the same regular session as the transfer
6	depositing such moneys to the emergency and budget
7	reserve fund; provided that transfers shall not be made
8	to the emergency and budget reserve fund whenever the
9	balance of the emergency and budget reserve fund is
10	equal to or more than ten per cent of general fund
11	revenues for the preceding fiscal year. The transfer
12	shall be executed by the director of finance;
13	provided that all moneys deposited into the emergency and budget
14	reserve fund under paragraphs (1) and (2) and all moneys deposited
15	under paragraph (3) shall be kept in separate and distinct
16	accounts."
17	SECTION 2. Statutory material to be repealed is bracketed
18	and stricken. New statutory material is underscored.
19	SECTION 3. This Act shall take effect upon its approval.
