ACT 088 H.B. NO. 912 H.D. 2 S.D. 1

A BILL FOR AN ACT

RELATING TO NURSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that advanced practice
- 2 registered nurses are primary care providers who may practice to
- 3 the full scope of practice allowed under chapter 457, Hawaii
- 4 Revised Statutes. The legislature further finds that, as
- 5 licensed health care practitioners, advanced practice registered
- 6 nurses are qualified to provide primary medical care services to
- 7 adolescents and fulfill a vital role in caring for patients:
- 8 current and future health needs. The legislature additionally
- 9 finds that removing barriers to practice for advanced practice
- 10 registered nurses will result in improved access to safe,
- 11 timely, quality health care for the people of Hawaii.
- 12 The purpose of this Act is to allow advanced practice
- 13 registered nurses, who hold a national certification in a
- 14 psychiatric specialty, to offer care and services, similar to
- 15 those offered by physicians and other health care service
- 16 providers, to minors and patients in assisted community
- 17 treatment.

1	SECT	ION 2. Section 334-121, Hawaii Revised Statutes, is
2	amended t	o read as follows:
3	"§33	4-121 Criteria for assisted community treatment. A
4	person ma	y be ordered to obtain assisted community treatment if
5	the famil	y court finds that:
6	(1)	The person is mentally ill or suffering from substance
7		abuse; [and]
8	(2)	The person is unlikely to live safely in the community
9		without available supervision based on the
10		professional opinion of a psychiatrist[; and] or
11		advanced practice registered nurse with prescriptive
12		authority and who holds an accredited national
13		certification in an advanced practice registered nurse
14		psychiatric specialization;
15	(3)	The person, at some time in the past: (A) has
16		received inpatient hospital treatment for mental
17		illness or substance abuse or (B) has been found to be
18		imminently dangerous to self or others, as a result of
19		mental illness or substance abuse; [and]
20	(4)	The person, based on the person's treatment history
21		and current condition, is now in need of treatment in

1		order to prevent a relapse or deterioration which
2		would predictably result in the person becoming
3		imminently dangerous to self or others; [and]
4	(5)	The person has a history of a lack of adherence to
5		treatment for mental illness or substance abuse, and
6		the person's current mental status or the nature of
7		the person's disorder limits or negates the person's
8		ability to make an informed decision to voluntarily
9		seek or comply with recommended treatment; [and]
10	(6)	The assisted community treatment is medically
11		appropriate, and in the person's medical interests;
12		and
13	(7)	Considering less intrusive alternatives, assisted
14		community treatment is essential to prevent the danger
15		posed by the person."
16	SECT	ION 3. Section 334-122, Hawaii Revised Statutes, is
17	amended by adding a new definition to be appropriately inserted	
18	and to read as follows:	
19	" "Ad	vanced practice registered nurse" means a registered
20	nurse lic	ensed to practice in this State who:

1	(1)	Has met the qualifications set forth in chapter 457	
2		and this part;	
3	(2)	Because of advanced education and specialized clinical	
4		training, is authorized to assess, screen, diagnose,	
5		order, utilize, or perform medical, therapeutic,	
6		preventive, or corrective measures;	
7	(3)	Holds an accredited national certification in an	
8		advanced practice registered nurse psychiatric	
9		specialization; and	
10	(4)	Holds prescriptive authority pursuant to section 457-	
11		<u>8.6."</u>	
12	SECT	ION 4. Section 334-123, Hawaii Revised Statutes, is	
13	amended b	y amending subsection (b) to read as follows:	
14	" (b)	The petition may be accompanied by a certificate of a	
15	licensed	psychiatrist or advanced practice registered nurse with	
16	prescript	prescriptive authority and who holds an accredited national	
17	certifica	tion in an advanced practice registered nurse	
18	psychiatr	ic specialization who has examined the subject of the	
19	petition	within twenty calendar days prior to the filing of the	
20	petition.	For purposes of the petition, an examination shall be	
21	considere	d valid so long as the licensed psychiatrist or

- 2 and who holds an accredited national certification in an
- 3 advanced practice registered nurse psychiatric specialization
- 4 has obtained enough information from the subject of the petition
- 5 to reach a diagnosis of the subject of the petition, and to
- 6 express a professional opinion concerning the same, even if the
- 7 subject of the petition is not fully cooperative."
- 8 SECTION 5. Section 334-126, Hawaii Revised Statutes, is
- 9 amended by amending subsection (h) to read as follows:
- 10 "(h) No subject of the petition shall be ordered to
- 11 receive assisted community treatment unless at least one
- 12 psychiatrist or advanced practice registered nurse with
- 13 prescriptive authority and who holds an accredited national
- 14 certification in an advanced practice registered nurse
- 15 psychiatric specialization testifies in person at the hearing
- 16 who has personally assessed the subject, within a reasonable
- 17 time before the filing of the petition up to the time when the
- 18 psychiatrist or advanced practice registered nurse with
- 19 prescriptive authority and who holds an accredited national
- 20 certification in an advanced practice registered nurse
- 21 psychiatric specialization provides oral testimony at court.

- 1 The [psychiatrist's] testimony of the psychiatrist or advanced
- 2 practice registered nurse with prescriptive authority and who
- 3 holds an accredited national certification in an advanced
- 4 practice registered nurse psychiatric specialization shall state
- 5 the facts which support the allegation that the subject meets
- 6 all the criteria for assisted community treatment, provide a
- 7 written treatment plan, which shall include non-mental health
- 8 treatment if appropriate, provide the rationale for the
- 9 recommended treatment, and identify the designated mental health
- 10 program responsible for the coordination of care.
- 11 If the recommended assisted community treatment includes
- 12 medication, the [psychiatrist's] testimony of the psychiatrist
- 13 or advanced practice registered nurse with prescriptive
- 14 authority and who holds an accredited national certification in
- 15 an advanced practice registered nurse psychiatric specialization
- 16 shall describe the types or classes of medication which should
- 17 be authorized, and describe the physical and mental beneficial
- 18 and detrimental effects of such medication."
- 19 SECTION 6. Section 334-127, Hawaii Revised Statutes, is
- 20 amended by amending subsections (b) and (c) to read as follows:

1 If after hearing all relevant evidence, including the 2 results of any diagnostic examination ordered by the family 3 court, the family court finds that the criteria for assisted community treatment under section 334-121(1) have been met beyond a reasonable doubt and that the criteria under section 5 6 334-121(2) to 334-121(7) have been met by clear and convincing 7 evidence, the family court shall order the subject to obtain assisted community treatment for a period of not more than one 9 year. The written treatment plan submitted pursuant to section 10 334-126(h) shall be attached to the order and made a part of the 11 order. 12 If the family court finds by clear and convincing evidence 13 that the beneficial mental and physical effects of recommended 14 medication outweigh the detrimental mental and physical effects, 15 if any, the order may authorize types or classes of medication 16 to be included in treatment at the discretion of the treating 17 psychiatrist[-] or advanced practice registered nurse with 18 prescriptive authority and who holds an accredited national 19 certification in an advanced practice registered nurse

- 19 accredited national certification in an advanced practice
- 20 registered nurse psychiatric specialization may prescribe or
- 21 administer to the subject of the order reasonable and

- 1 appropriate medication or medications, if specifically
- 2 authorized by the court order, and treatment which is consistent
- 3 with accepted medical standards and the family court order,
- 4 including the written treatment plan submitted pursuant to
- 5 section 334-126(h)."

- 7 "(d) The designated mental health program's treating
- 8 psychiatrist or advanced practice registered nurse with
- 9 prescriptive authority and who holds an accredited national

- 12 psychiatrist or advanced practice registered nurse with

- 6 hospitalization."
- 7 SECTION 8. Section 334-131, Hawaii Revised Statutes, is
- 8 amended by amending subsection (a) to read as follows:
- 9 "(a) When the treating psychiatrist or advanced practice
- 10 registered nurse with prescriptive authority and who holds an
- 11 accredited national certification in an advanced practice
- 12 registered nurse psychiatric specialization contemplates
- 13 discharge for a subject of the order because of expiration of
- 14 the court order or because the subject of the order is no longer
- 15 a proper subject for assisted community treatment, as determined
- 16 by the criteria in section 334-121, the treating psychiatrist or
- 17 advanced practice registered nurse with prescriptive authority
- 18 and who holds an accredited national certification in an

- 20 shall provide notice of intent to discharge."

8	(2)	A person licensed as a marriage and family therapist
9		pursuant to chapter 451J;

14	(5)	A board certified, or board eligible, licensed
15		psychiatrist[+]; or

1 "Mental health treatment or counseling services" means the 2 provision of outpatient mental health treatment or counseling by 3 a licensed mental health professional." 4 SECTION 10. Section 577A-2, Hawaii Revised Statutes, is 5 amended to read as follows: 6 "§577A-2 Consent valid. The consent to the provision of 7 medical care and services by public and private hospitals or 8 public and private clinics, or the performance of medical care 9 and services by a physician licensed to practice medicine[7] or 10 advanced practice registered nurse as defined in section 11 457-2.7, when executed by a female minor who is or professes to 12 be pregnant, or by a minor who is or professes to be afflicted 13 with a venereal disease, or a minor seeking family planning 14 services shall be valid and binding as if the minor had achieved 15 his or her majority as the case may be; that is, a female minor who is, or professes to be pregnant, or a minor who is, or 16 17 professes to be afflicted with a venereal disease, or a minor 18 seeking family planning services shall be deemed to have, and 19 shall have the same legal capacity to act, and the same legal 20 obligations with regard to the giving of such consent to such 21 hospitals and such clinics or medical care and services to be

- 20 inform the spouse, parent, custodian, or guardian of any minor
- 21 patient of the provision of medical care and services to the

- 1 minor or disclose any information pertaining to such care and
- 2 services after consulting with the minor patient to whom such
- 3 medical care and services have been provided under this chapter.
- 4 If the minor patient is not diagnosed as being pregnant or
- 5 afflicted with venereal disease, such information as well as the
- 6 application for diagnosis may be disclosed, at the discretion of
- 7 the treating physician or advanced practice registered nurse
- 8 after consulting with the minor patient."
- 9 SECTION 12. Section 577A-4, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "§577A-4 Financial responsibility; counseling. (a) If a
- 12 minor consents to receive medical care and services, the spouse,
- 13 parent, custodian, or quardian of the minor patient shall not be
- 14 liable for the legal obligations resulting from the furnishing
- 15 of medical care and services provided by the public and private
- 16 hospital, [ex] public and private clinic or physician licensed
- 17 to practice medicine [-], or advanced practice registered nurse
- 18 as defined in section 457-2.7. A minor who consents to the
- 19 provision of medical care and services under this section shall
- 20 assume financial responsibility for the costs of such medical
- 21 care and services. Any other law to the contrary

- 1 notwithstanding, no spouse, parent, custodian, or guardian whose
- 2 consent has not been obtained or who has no prior knowledge that
- 3 the minor has consented to the provision of such medical care
- 4 and services shall be liable for the costs incurred by virtue of
- 5 the minor's consent.
- 6 (b) Medical care and services shall include individual
- 7 counseling for each minor patient by a physician licensed to
- 8 practice medicine[+] or advanced practice registered nurse as
- 9 defined in section 457-2.7. Such counseling shall seek to open
- 10 the lines of communication between parent and child."
- 11 SECTION 13. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 14. This Act shall take effect upon its approval.
