

A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Pohoiki bay harbor, at Isaac Hale beach park,
- 2 is the only harbor in the lower portion of the Puna district of
- 3 the island of Hawaii. The harbor includes a one-lane boat ramp
- 4 and a ninety-foot breakwater. The harbor can only accommodate
- 5 small boats, and launching them can be difficult because of the
- 6 harbor's small size and the rough ocean conditions that are
- 7 often present.
- 8 The legislature finds that in 2014, lava flow had
- 9 threatened to cross Highway 130 in the county of Hawaii,
- 10 possibly preventing fifteen to twenty thousand households from
- 11 going to school or work and denying them access to the nearby
- 12 hospital. A ferry from the Pohoiki bay harbor was deemed not
- 13 feasible because of ingress and egress dangers posed by the
- 14 surf.
- 15 The legislature further finds that Kapoho bay, near the
- 16 eastern tip of the Puna district, is a naturally protected bay

- 1 where it may be feasible to establish a harbor or port to
- 2 accommodate vessels that transport cargo and passengers.
- 3 Accordingly, the purpose of this Act is to require the
- 4 director of transportation to contract for a feasibility study
- 5 for a harbor or port at Kapoho bay.
- 6 SECTION 2. The director of transportation shall contract
- 7 for a study to determine the feasibility of establishing a
- 8 harbor or port at Kapoho bay to accommodate vessels that
- 9 transport cargo and passengers. The department shall submit a
- 10 report to the legislature with preliminary findings and
- 11 recommendations, including any proposed legislation, not later
- 12 than twenty days prior to the convening of the regular session
- 13 of 2018 and a final report with findings and recommendations,
- 14 including any proposed legislation, not later than twenty days
- 15 prior to the convening of the regular session of 2019.
- 16 SECTION 3. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$200,000 or so much
- 18 thereof as may be necessary for fiscal year 2017-2018 and the
- 19 same sum or so much thereof as may be necessary for fiscal year
- 20 2018-2019 for the purposes of this Act.

- The sums appropriated shall be expended by the department 1
- of transportation for the purposes of this Act. 2
- SECTION 4. This Act shall take effect on July 1, 2017. 3
