### A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE II, SECTION 1, OF THE HAWAII STATE CONSTITUTION TO CHANGE THE AGE QUALIFICATION FOR VOTING IN STATE OR LOCAL ELECTIONS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the age qualification to vote in any federal, state, or local election 2 3 is eighteen years of age. However, there are individuals whose dates of birth fall between the primary and general elections 4 5 and therefore, due to current age restrictions, are unable to participate in state and local primary elections, which 6 7 determine the ballot for the general election in which they will later be eligible to vote. Granting voting rights to these 8 individuals to participate in the voting process for state and 9 local elections may improve voter turnout among youths and 10 better educate youths about the democratic process. 11 12 The purpose of this Act is to propose an amendment to article II, section 1, of the Hawaii State Constitution to 13 change the age qualification for voting in certain state or 14

SECTION 5. This amendment shall take effect upon compliance with article XVII, section 3, of the Constitution of the State of Hawaii.
