BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. (a) The state procurement office, in
 conjunction with the department of education, the University of
- 3 Hawaii, the department of transportation, and the department of
- 4 accounting and general services, shall conduct a comprehensive
- 5 analysis and review of the Hawaii public procurement code,
- 6 particularly with regard to the awarding of construction
- 7 contracts.
- 8 (b) At a minimum, the analysis and review shall include:
- 9 (1) A review of issues and concerns regarding the Hawaii
- 10 public procurement process that were raised by the
- 11 task force established by the comptroller, pursuant to
- senate concurrent resolution no. 92, senate draft 2,
- regular session of 2013, in the task force's final
- report issued on April 14, 2015, and submitted to the
- 15 legislature during the regular session of 2015;
- 16 (2) A review of federal procurement laws, particularly
- 17 title 48 Code of Federal Regulations chapter 1,

- 3 2018-2019 for a comprehensive review and analysis of the Hawaii
- 4 public procurement code, particularly with regard to the

- 6 The sums appropriated shall be expended by the state
- 7 procurement office for the purposes of this Act.
- 8 SECTION 3. This Act shall take effect on July 1, 2050.
