## A BILL FOR AN ACT

RELATING TO THE ELECTRONIC DEVICE RECYCLING FUND.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 339D-10, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+] §339D-10[+] Electronic device recycling fund. (a)
- 4 There is established in the state treasury the electronic device
- 5 recycling fund into which shall be deposited all fees, payments,
- 6 and penalties collected by the department pursuant to this
- 7 chapter.
- 8 (b) The electronic device recycling fund shall be
- 9 administered by the department of health. Moneys in the fund
- 10 shall be expended by the director [solely] for the purpose of
- 11 implementing and enforcing this chapter. Moneys may also be
- 12 expended by the director to support county electronics
- 13 collections."
- 14 SECTION 2. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so
- 16 much thereof as may be necessary for fiscal year 2017-2018 and
- 17 the same sum or so much thereof as may be necessary for fiscal

- 1 year 2018-2019 to be deposited into the electronic device
- 2 recycling fund.
- 3 SECTION 3. There is appropriated out of the electronic
- 4 device recycling fund the sum of \$ or so much thereof
- 5 as may be necessary for fiscal year 2017-2018 and the same sum
- 6 or so much thereof as may be necessary for fiscal year 2018-2019
- 7 for the director of health to reimburse the counties of Hawaii,
- 8 Kauai, and Maui for expenses incurred during 2015 and 2016

Electronic Device Recycling Fund; Uses; Appropriation

#### Description:

Authorizes the Director of Health to expend moneys to support county electronics recycling collection. Appropriates general funds for deposit into the electronic device recycling fund. Appropriates funds from the electronic device recycling fund to reimburse the counties of Hawaii, Kauai, and Maui for expenses incurred during 2015 and 2016 related to the collection services associated with handling and collecting electronic devices for recycling. Effective 07/01/2050. (SD2)
