A BILL FOR AN ACT

RELATING TO LEGISLATIVE ALLOWANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 24-2, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "§24-2 Allowance for non-Oahu legislator during session. A member of the legislature whose legal residence is on an 4 5 island other than Oahu shall receive an additional allowance to 6 cover all personal expenses such as board, lodging, and 7 incidental expenses but not travel expenses. The allowance 8 under this section shall be set at a single rate that [will: 9 (1) Not exceed the greater of the maximum allowance for 10 such expenses payable to any public officer or 11 employee of the federal government or the State; 12 (2) Be reasonably calculated to cover the expenses 13 specified in this section; and 14 (3) Be determined jointly by the president of the senate 15 and the speaker of the house of representatives for 16 the legislature as a whole.]

1 is equal to the federal Department of Defense flat rate per diem 2 amount for the island of Oahu for temporary duty assignments of 3 thirty-one to one hundred eighty days. 4 The allowance shall be paid to each member at the rate 5 prescribed for each day, from the first to the last day of each 6 session, including Saturdays, Sundays, holidays, and days of 7 recess pursuant to the mandatory recess required by article III, 8 section 10, of the Constitution or a concurrent resolution, 9 except for days of recess when a session of the legislature is 10 recessed for more than three days pursuant to a concurrent 11 resolution and for days of unexcused absence of the member from 12 a meeting of the respective house." 13 SECTION 2. Section 24-4, Hawaii Revised Statutes, is 14 amended to read as follows: 15 "§24-4 Allowance for expenses while on official 16 legislative business during period of recess and interim 17 official legislative business. Legislative Allowance; Flat Rate Per Diem; Recess; Interim

Description:

Specifies that the per diem legislative allowance for legislators who reside on an island other than Oahu shall be equal to the federal Department of Defense flat rate per diem amount for temporary duty on Oahu. Authorizes a similar allowance to cover incidental expenses incurred by Oahu-based legislators conducting official business during certain recess and interim periods. (HB1354 HD1)
