A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The purpose of this Act is to empower the SECTION 1. 2 teachers and administrators of Hawaii by forming an "education 3 advisory council" composed of current educators and 4 administrators. The council shall have the authority to make 5 decisions regarding educational policy, curriculum and 6 performance standards for public schools. 7 SECTION 2. Section 302A-1101, Hawaii Revised Statutes, is 8 amended to read as follows: 9 "§302A-1101 Department of education; board of education; 10 superintendent of education. (a) There shall be a principal 11 executive department to be known as the department of education, 12 which shall be headed by a [policy-making] board to be known as 13 the board of education. The board [shall] may have power in 14 accordance with law to formulate statewide educational policy, 15 adopt student performance standards and assessment models, 16 monitor school success, and appoint the superintendent of

education as the chief executive officer of the public school
 system.

3 (b) The board shall appoint, and may remove, the
4 superintendent by a majority vote of its members. The
5 superintendent:

6 (1) May be appointed without regard to the state residency
7 provisions of section 78-1(b);

8 (2) May be appointed for a term of up to four years; and
9 (3) May be terminated only for cause.

10 The board shall invite the senior military commander (c) 11 in Hawaii to appoint a nonvoting military representative to the 12 board, who shall serve for a two-year term without compensation. 13 As the liaison to the board, the military representative shall 14 advise the board regarding state education policies and 15 departmental actions affecting students who are enrolled in 16 public schools as family members of military personnel. The 17 military representative shall carry out these duties as part of 18 the representative's official military duties and shall be 19 quided by applicable state and federal statutes, regulations, 20 and policies and may be removed only for cause by a majority 21 vote of the members of the board.
