A BILL FOR AN ACT

RELATING TO PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Small businesses are the lifeblood of the
- 2 State's economy. Act 50, Session Laws of Hawaii 2005, was
- 3 enacted to promote the growth and development of small
- 4 businesses in Hawaii through the establishment of a small
- 5 business preference program as part of the procurement process.
- 6 Additionally, Act 213, Session Laws of Hawaii 2007, approved the
- 7 funding for a full-time position in the state procurement office
- 8 with the purpose of implementing part IX (assistance to small
- 9 business), chapter 103D, Hawaii Revised Statutes.
- 10 Unfortunately, due to funding and staffing cuts in 2008, this
- 11 position was never filled and was eliminated from the state
- 12 procurement office. Although section 3-124-73, Hawaii
- 13 Administrative Rules, and related interim small business
- 14 preference rules went into effect in 2007, a dedicated position
- 15 to carry out those rules was lacking. In the absence of this
- 16 dedicated position or a small business office, these interim

- 1 rules failed to help the small business community and the rules
- 2 expired in 2011.
- 3 The legislature finds that small businesses owned by
- 4 veterans, native Hawaiians, and women are the most vulnerable
- 5 and disadvantaged businesses within our State. The legislature
- 6 further finds that an initiative is needed to identify,
- 7 quantify, and address the needs of these small businesses and to
- 8 measure and track their present participation in state small
- 9 business contracts.
- 10 The legislature further finds that the State must create,
- 11 develop, and implement strategies to ensure that small
- 12 businesses, including businesses owned by veterans, native
- 13 Hawaiians, and women, are able to effectively participate in
- 14 small business contracting opportunities within our State.
- 15 The legislature further finds that previously developed
- 16 administrative rules with respect to the development of small
- 17 business contracts with the State were not effective because of
- 18 a lack of appropriate business metrics and data available to
- 19 provide relevant information necessary for the creation of those
- 20 rules.

- 1 The legislature finds that any solution to address small
- 2 business concerns in the State must be attempted incrementally.
- 3 The legislature further finds that the state procurement office
- 4 is now ready to address part IX of the Hawaii Public Procurement
- 5 Code and assist self-identified small businesses in obtaining
- 6 state contracts. The legislature intends to facilitate this
- 7 process by creating a small business assistance initiative to
- 8 convene small business stakeholders, collect and develop
- 9 relevant data and information necessary for small businesses to
- 10 compete for and obtain small business contracts, and identify
- 11 and resolve issues that must be addressed to develop an
- 12 effective small business state contracting program within the
- 13 state procurement process.
- 14 The purpose of this Act is to establish the small business
- 15 assistance initiative and provide staffing for the
- 16 implementation of part IX (assistance to small business),
- 17 chapter 103D, Hawaii Revised Statutes.
- 18 SECTION 2. (a) There is established, within the state
- 19 procurement office, a three-year small business assistance
- 20 initiative to facilitate the collection and development of
- 21 relevant data and information and convene stakeholders for the

- 1 development of an effective small business program, including
- 2 the development of rules.
- 3 (b) The small business assistance initiative shall consist
- 4 of a small business procurement coordinator, a small business
- 5 office, and a small business advisory group.
- 6 (c) There is established, as part of the small business
- 7 assistance initiative established under subsection (a), a small
- 8 business advisory group. The small business advisory group
- 9 shall be convened by the chief procurement officer of the State,
- 10 shall consist of members from state agencies, non-profit
- 11 entities, and local businesses, and shall be staffed by the
- 12 state procurement office. The small business advisory group
- 13 shall:
- 14 (1) Meet regularly to discuss the progress of the
- initiative and to investigate any substantial problems
- brought to the attention of the group;
- 17 (2) Recommend parameters to expand the initiative's policy
- 18 to include other methods of procurement or other
- substantive improvements;
- 20 (3) Recommend the placement and scope, administrative
- 21 definition, staffing, and funding requirements for a

1		state small business office designed to help small
2		businesses better utilize a state small business
3		program;
4	(4)	Recommend the disposition of the small business
5		procurement coordinator, including continuing the
6		position of small business procurement coordinator as
7		a civil service exempt position, converting the
8		position to a full time civil service position, or
9		placing the position outside of the initiative;
10	(5)	Recommend goals that should be established to award a
11		percentage of state annual expenditures to identified
12		veteran, native Hawaiian, and female owned businesses
13		based on metrics established by the small business
14		advisory group;
15	(6)	Recommend the appropriate next steps for a state small
16		business program as it looks to fully implement
17		section 103D-906, Hawaii Revised Statutes;
18	(7)	Undertake and complete a study to determine the
19		viability of transferring the functions of the small
20		business office to an office within an existing state
21		department and submit the study and final

1	recommendation to the procurement policy board and to
2	the legislature in the report described in paragraph
3	(9);

- (8) Use data received from the small business procurement coordinator and small business office to make recommendations for rules to be developed by the chief procurement officer and the procurement policy board; and
- By November 30, 2020, draft, publish, and disseminate 9 (9) 10 to the procurement policy board, the legislature, and 11 the public a final report of all the recommendations, 12 observations, and metrics related to the initiative, 13 as well as the initiative's success in encouraging and 14 increasing small business participation in the state 15 procurement process and the amount of state contracts being awarded to small businesses. 16
- 17 (d) There is established the position of small business
 18 procurement coordinator within the state procurement office,
 19 which shall be exempt from chapter 76, Hawaii Revised Statutes.
 20 The small business procurement coordinator, with the assistance
 21 of the small business office, shall be responsible for the

1 collection and maintenance of data from the state small busines

- 2 database, the provision of this data and metrics to the small
- 3 business advisory group, and the daily operations of the small
- 4 business assistance initiative established in subsection (a).
- 5 The small business procurement coordinator shall also be
- 6 responsible for implementing programs and procedures to carry
- 7 out the intent of part IX, chapter 103D, Hawaii Revised
- 8 Statutes, to assist small businesses, including:
- 9 (1) Establishing and maintaining a statewide small
- business database;
- (2) Establishing and managing a small businessregistration, certification, and identification
- process;
- 14 (3) Drafting policies and rules to assist in the
- implementation of part IX, chapter 103D, Hawaii
- 16 Revised Statutes;
- 17 (4) Producing, publishing, and disseminating training
- 18 materials designed to inform procurement staff and
- 19 self-identified small business vendors of all small
- business programs and opportunities;

1	(5)	Conducting surveys of, and collecting feedback from,
2		procurement staff and self-identified small business
3		vendors to be presented to the small business advisory
4		group and chief procurement officer of the State; and
5	(6)	Producing an annual report of small business
6		participation metrics and data to be submitted to the
7		small business advisory group.
8	(e)	There is established, as part of the initiative under
9	subsectio	n (a) and within the state procurement office, a small
10	business	office. A contract to hire a firm to perform the
11	operation	s and maintenance of the small business office for the
12	duration	of the initiative shall be executed. The contract
13	shall be	awarded to an existing Hawaii-based small business
14	advocacy	group with experience in helping small businesses
15	obtain st	ate and federal contracts. The awardee shall be a
16	small bus	iness owned by a native Hawaiian, veteran, or female
17	and shall	have an understanding of the small business community
18	to be abl	e to meet the requirements of the small business
19	initiativ	e. Staff of the small business office shall be
20	responsib	le for:

1	(1)	Providing timely training and reports relating to key
2		developments in the small business community;
3	(2)	Establishing communications with self-identified
4		vendors which may include developing and implementing
5		a newsletter and email campaign to keep vendors
6		informed of current small business events;
7	(3)	Producing and publicizing outreach campaigns related
8		to the small business initiative and other small
9		business programs and opportunities as may be
10		developed or discovered;
11	(4)	Creating, developing, advertising, and encouraging
12		vendor participation in workshops, seminars, and
13		training designed to promote and enhance small
14		business participation in state contracts;
15	(5)	Establishing mechanisms and implementing procedures
16		for conducting audits, handling disputes, and
17		investigating allegations of fraud and other
18		misappropriations of the small business initiative and
19		its benefits to small businesses;
20	(6)	Aggregating all small business resources and materials
21		from around the state and presenting them in an easily

1		accessible and understandable online format by
2		potential vendor participants;
3	(7)	Coordinating with small business advocates in the
4		public and private sectors to create a small business
5		network that can be easily accessed by all small
6		businesses;
7	(8)	Answering small business vendors' emails and questions
8		about the State's existing small business programs;
9		and
10	(9)	Collecting data on existing and future small business
11		vendor disputes, problems, difficulties, successes,
12		recommendations, and any other metrics deemed
13		important to the initiative by the state procurement
14		office or legislature.
15	(f)	The small business assistance initiative shall cease
16	to exist	on June 30, 2020; provided that the small business
17	advisory	group shall remain responsible for submitting a report
18	pursuant	to subsection (c)(9).
19	SECT	ION 3. There is appropriated out of the general
20	revenues	of the State of Hawaii the sum of \$ or so much
21	thereof a	s may be necessary for fiscal year 2017-2018 and the

1	same sum	or so much thereof as may be necessary for fiscal year
2	2018-2019	for assisting small businesses; provided that of the
3	sums appr	opriated:
4	(1)	\$ shall be used to complete the state small
5		business database;
6	(2)	\$ shall be used for the establishment of one
7		full-time equivalent (1.00 FTE) permanent small
.8		business procurement coordinator position exempt from
9		chapter 76, Hawaii Revised Statutes, in the state
10		procurement office; and
11	(3)	\$ shall be used for the hiring of a local
12		small business to operate and maintain the small
13		business office and for marketing of and outreach for
14		the small business assistance initiative.
15	The	sums appropriated shall be expended by the state
16	procureme	nt office for the purposes of this Act.
17	SECT	ION 4. This Act shall take effect on July 1, 2050 and
18	shall be	repealed on June 30, 2020.
