A BILL FOR AN ACT

RELATING TO EMERGENCY MEDICAL SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

SECTION 1. The legislature finds that anti-tobacco campaigns have played a major role in the overall decline of cigarette smoking. A key tool of tobacco use control has been taxation policy, which has been shown to be particularly effective for youths, who are generally more price-sensitive, and thus are less likely to start or maintain cigarette smoking when it is expensive.

9 The health effects of smoking are well established and 10 include increased risk of heart attack, stroke, and other 11 medical events to which Hawaii's emergency medical services 12 system routinely responds. A clear nexus thus exists between 13 cigarette smoking and utilization of the emergency healthcare 14 system. However, due to declining rates of smoking, the long-15 term sustainability of the cigarette tax as a revenue source for 16 the emergency medical system special fund is not guaranteed.

1 The purpose of this part is to repeal the emergency medical 2 services special fund, redirect the fund's revenue sources, 3 which are the cigarette tax, motor vehicle registration fee, and 4 investment pool returns, to the general fund, and appropriate an 5 equal dollar amount to the department of health for purposes of 6 overseeing the state comprehensive emergency medical system with 7 no discernable disruptions.

8 In fiscal year 2015-2016, emergency medical services
9 special fund revenues from cigarette sales were \$8,800,000;
10 revenues from vehicle registration fees were \$6,538,865; and
11 revenues from the investment pool account were \$151,502.46.
12 Total emergency medical system special fund revenues in fiscal
13 year 2015-2016 were \$15,490,367.46.

14 SECTION 2. Section 245-15, Hawaii Revised Statutes, is 15 amended to read as follows:

16 SECTION 10. The legislature finds that a high percentage 17 of calls for emergency medical services are from repeat callers 18 who call multiple times per day for issues that do not require 19 an emergency response. Most 911 calls originate from residences 20 and many involve medical concerns that could be addressed by a 21 functioning community paramedic system. The volume of calls for

1 emergency medical services rises each year due to growth in 2 population and tourism and often outpaces the availability of 3 resources. Therefore, it is critical to establish community 4 paramedic services to provide appropriate services to non-5 emergency callers who would otherwise be using valuable 6 emergency medical services needed by other individuals.

7 For these reasons, the legislature adopted House Concurrent 8 Resolution No. 90 during the regular session of 2016. This 9 resolution requested that the chief of the department of 10 health's emergency medical services and injury prevention system 11 branch convene and chair a working group to develop a community 12 paramedic program, including educational standards for 13 certifications, to relieve emergency services personnel from the 14 obligation to respond to non-emergency calls.

15 The working group, in its December 2016 report to the 16 legislature, recommended that a community paramedic services 17 pilot program be established at two to three of the six 18 metropolitan and rural sites it identified. The working group 19 found that community paramedicine could reduce the high volume 20 of 911 calls for non-emergent medical conditions. It also found 21 that community paramedicine could improve health in the State by



addressing calls involving non-emergency services, post hospital 1 2 discharge care, the homeless population, hospice care, behavioral health, and acute and chronic medical conditions such 3 4 as infectious diseases, diabetes, hypertension, and asthma. 5 The purpose of this part is to implement the 6 recommendations of the working group convened pursuant to House Concurrent Resolution No. 90, regular session of 2016, by 7 establishing and appropriating funds for a three-year community 8 paramedic services pilot program and requiring an evaluation of 9 10 the program's effectiveness. SECTION 11. (a) There is established a three-year 11 12 community paramedic services pilot program, to be administered 13 by the department of health. The pilot program shall commence on July 1, 2017, and shall terminate on June 30, 2020. The 14 program shall be conducted at two to three pilot sites approved 15 by the director of health.
