### A BILL FOR AN ACT

RELATING TO CROSSWALKS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) There is established within the department 2 of transportation a community crosswalks pilot program, which 3 shall design and implement a specially painted crosswalk that 4 represents a neighborhood's unique culture and promotes 5 pedestrian safety, in collaboration with the appropriate county 6 departments and agencies, as determined by the director of 7 transportation. 8 The department shall designate a crosswalk within the 9 Waipahu school complex area to be used for the pilot program, 10 provided that the crosswalk: 11 Must be at a location that is already a marked 12 crosswalk, and where a vehicle is required to stop, **13** either due to a stop sign or traffic signal; 14
  - (2) To the extent possible, shall be located at an intersection with shorter width between streets and that experiences lower traffic volume; and
- 17 (3) Is located on pavement that is in good condition.
