9	one representative on the board from any one unit."
10	SECTION 2. Section 514B-123, Hawaii Revised Statutes, is
11	amended by amending subsection (d) to read as follows:
12	"(d) A proxy, to be valid, shall:
13	(1) Be delivered to the secretary of the association or
14	the managing agent, if any, no later than 4:30 p.m. on
15	the second business day prior to the date of the
16	meeting to which it pertains;
