## A BILL FOR AN ACT

RELATING TO IDENTIFICATION CARDS FOR PERSONS WITH DISABILITIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that persons with
  disabilities have the desire to indicate their disability on
  their identification cards, such as the State of Hawaii
- 4 identification card, driver's license, or an identification card
- 5 for persons with disabilities. Because not all disabilities are
- 6 outwardly visible, the disclosure of a disability on a driver's
- 7 license or identification card can assist first responders in
- 8 determining the best way to treat, assist, or communicate with
- 9 the person.
- 10 Having a license or identification card clearly indicating
- 11 a person's disability will allow the person access to certain
- 12 services such as special seating on public transit or at public
- 13 events. The "disabled" notification on the card indicates that
- 14 a person has a disability and does not take the place of
- 15 existing public service qualification procedures. To mitigate
- 16 potential abuse, medical documentation is required to support a

- 1 person's request for indication of a disability on their
- 2 identification card.
- 3 Those who choose to include information about their
- 4 disability on their driver's license, state identification card,
- 5 and identification card for persons with disabilities may do so
- 6 under this Act.
- 7 SECTION 2. Chapter 286, Hawaii Revised Statutes, is
- 8 amended by adding a new section to part VI to be appropriately
- 9 designated and to read as follows:
- 10 "§286- Driver's license for persons with disabilities.
- 11 Persons with disabilities may opt to identify their disability
- on their driver's license; provided that the person requesting
- 13 its inclusion first submit documentation of their disability, as
- 14 determined by the examiner of drivers. The driver's license
- 15 shall display the "disabled" notation on a location designated
- 16 by the department of transportation."
- 17 SECTION 3. Chapter 286, Hawaii Revised Statutes, is
- 18 amended by adding a new section to part XVI be appropriately
- 19 designated and to read as follows:
- 20 "§286- Identification card for persons with
- 21 disabilities. (a) The department of transportation shall issue



- 1 identification cards to persons with disabilities pursuant to
- 2 section 286-305.
- 3 (b) The identification card for persons with disabilities
- 4 shall include characteristics and content pursuant to section
- 5 286-305. On the reverse side of the identification card shall
- 6 be a space within which the department shall enter such
- 7 disability information the applicant may request.
- 8 (c) The department may include a notation of disability
- 9 status, if desired by the applicant, on the front and may print
- 10 the disability information on the reverse on any driver's
- 11 license or identification card issued pursuant to the provisions
- of this chapter upon receipt of the required documentation from
- 13 the person requesting its inclusion.
- 14 (d) An identification card for persons with a temporary
- 15 disability shall be issued upon presentation of a sworn
- 16 affidavit of at least one medical doctor attesting to such
- 17 disability and estimating the duration of the disability.
- 18 Identification cards indicating temporary disabilities shall be
- 19 issued for periods of one year, and a current affidavit of a
- 20 medical doctor attesting to the continuance of such disability
- 21 shall be presented at each request thereafter."



- 1 SECTION 4. Section 286-2, Hawaii Revised Statutes, is
- 2 amended by adding two new definitions to be appropriately
- 3 inserted and to read as follows:
- 4 ""Disability" means any physical, mental, or neurological
- 5 impairment that severely restricts a person's mobility, manual
- 6 dexterity, or ability to climb stairs; substantial loss of sight
- 7 or hearing; loss of one or more limbs or use thereof; or
- 8 significantly diminished reasoning capacity.
- 9 "Person with disabilities" means any person with a
- 10 permanent or temporary disability."
- 11 SECTION 5. Section 286-305, Hawaii Revised Statutes, is
- 12 amended to read as follows:
- 13 "§286-305 Contents and characteristics; form. (a) Each
- 14 identification card issued by the examiner of drivers shall
- 15 display a distinguishing number assigned to the cardholder, and
- 16 shall display the following inscription:
- 17 "STATE OF HAWAII IDENTIFICATION CARD"
- 18 (b) The examiner of drivers, after obtaining the
- 19 fingerprint of the applicant as provided in this part and after
- 20 obtaining the information required by or pursuant to this part,
- 21 shall issue to each applicant an identification card in a form



- 1 and with identifying information that the director deems
- 2 necessary and appropriate, including a notation of veteran
- 3 status, if desired by the applicant, on the front of the card
- 4 where applicable; provided that such notation shall not include
- 5 any designation other than the term "veteran". As used in this
- 6 subsection, "veteran" means any person who served in any of the
- 7 uniformed services of the United States and was discharged under
- 8 conditions other than dishonorable.
- 9 (c) The identification card shall not display the
- 10 cardholder's social security number.
- (d) The identification card shall be designed to prevent
- 12 its reproduction or alteration without ready detection.
- 13 (e) The identification card for individuals under twenty-
- 14 one years of age shall have characteristics prescribed by the
- 15 examiner distinguishing it from that issued to [a] an individual
- 16 who is twenty-one years of age or older.
- 17 (f) Persons with disabilities may opt to identify their
- 18 disability on their identification card upon submission of the
- 19 required documentation to the examiner of drivers. The
- 20 identification card shall display a notation of disability
- 21 status, if desired by the applicant, on the front of the card
