

A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 291C, Hawaii Revised Statutes, is
2	amended by adding a new section to part XV to be appropriately
3	designated and to read as follows:
4	"§291C- Motor vehicle towing and storage; violations.
5	(a) A police officer citing or arresting a driver for any of
6	the following traffic violations may have the motor vehicle that
7	the driver was operating at the time of the citation or arrest
8	towed to a private tow yard and impounded at the registered
9	owner's expense pursuant to section 291C-165.5(a):
10	(1) Operating a vehicle under the influence of an
11	intoxicant, pursuant to section 291E-61; and
12	(2) Operating a vehicle after consuming a measurable
13	amount of alcohol; persons under the age of twenty-
14	one, pursuant to section 291E-64;
15	provided that the arresting officer has reason to believe the
16	arrested person is likely to return to the vehicle and continue

1	to drive under the influence of an intoxicant after being		
2	released from custody.		
3	(b)	Vehicles shall not be towed or impounded pursuant to	
4	this secti	on under any of the following circumstances:	
5	(1)	The motor vehicle is parked on private property on	
6		which the registered owner or operator is legally	
7		residing, or the property owner does not object to the	
8		motor vehicle being left in the parked location;	
9	(2)	The registered owner or a passenger present in the	
10		vehicle when the operator is arrested, or when a	
11		summons or citation is issued, has a valid driver's	
12		license and is willing and legally able to operate the	
13		motor vehicle;	
14	(3)	The motor vehicle is legally parked at a time and	
15		place where the likelihood of it being subject to	
16		theft or vandalism is remote and traffic or public	
17		safety is not impeded; or	
18	(4)	The motor vehicle is engaged in community caretaking	
19		at the time of the encounter. As used in this	
20		paragraph, "community caretaking" means any situation	
21		in which a law enforcement officer is using the	

1	vehicle for a consensual police-citizen encounter that	
2	is unrelated to the investigation or detection of any	
3	criminal activity.	
4	(c) No county police department or police officer shall be	
5	responsible for the protection of a motor vehicle left on any	
6	public way or private property after the motor vehicle's	
7	operator has been arrested for a violation listed in subsection	
8	<u>(a).</u> "	
9	SECTION 2. Section 291C-165.5, Hawaii Revised Statutes, is	
10	amended to read as follows:	
11	"§291C-165.5 Motor vehicle towing and storage; settlement.	
12	(a) Notwithstanding any other provision of this chapter, any	
13	vehicle identified for removal pursuant to any county ordinance	
14	or section 291C- ordering or authorizing removal of motor	
15	vehicles by any county police department for traffic violations,	
16	including a vehicle $[\frac{which}{c}]$ that constitutes an obstruction or	
17	hazard to traffic, may be towed away at the expense of the	
18	registered owner of the vehicle, as provided by this section.	
19	(b) The towing company shall determine the name of the	
20	lien holder and the registered owner of the vehicle from the	
21	department of transportation or the county department of	

1	finance. The lie	en holder and the registered owner shall be
2	notified by the t	cowing company in writing at the address on
3	record with the o	department of transportation or with the county
4	department of fir	nance by registered or certified mail of the
5	location of the	vehicle, together with a description of the
6	vehicle, within a	a reasonable period not to exceed twenty days
7	following the to	$_{\scriptscriptstyle W}$. The notice shall state:
8	(1) The max	ximum towing charges and fees allowed by law;
9	(2) The te	lephone number of the county finance department
10	that a	rranged for or authorized the tow; [and]
11	(3) That i	f the vehicle is not recovered within thirty
12	days a	fter the mailing of the notice, the vehicle
13	shall	be deemed abandoned and will be sold or disposed
14	of as	junk[+] ; and
15	(4) That t	he lien holder or registered owner may:
16	(A) <u>R</u>	ecover possession of the vehicle by paying the
17	<u>t</u>	owing and other fees allowed by law and file a
18	<u>1</u>	awsuit for damages with any court of competent
19	j	urisdiction as allowed by law; and
20	(B) <u>E</u>	emand an administrative hearing, before or after
21		the person has recovered possession of the

1	vehicle pursuant to subparagraph (A), to		
2	determine whether there was a sufficient factual		
3	and legal basis for removing the vehicle.		
4	Any towing company engaged in towing pursuant to this section		
5	shall comply with the requirements of section 291C-135. When		
6	the vehicle is recovered after the tow by the registered owner		
7	or lien holder, the party recovering the vehicle shall pay the		
8	tow and storage charges which shall not exceed the charges as		
9	provided by section 290-11(b) or the rates agreed upon with the		
10	respective counties, whichever is lower, except that tow		
11	operators may charge additional reasonable amounts for		
12	excavating vehicles from off-road locations; provided that if		
13	the notice required by this section was not sent within twenty		
14	days after the tow, neither the registered owner nor the lien		
15	holder shall be required to pay the tow and storage charges. No		
16	notice shall be sent to a legal or registered owner or any		
17	person with any unrecorded interest in the vehicle whose name or		
18	address cannot be determined. A person, including but not		
19	limited to the owner's or driver's insurer, who has been charged		
20	in excess of the charges permitted under this section may sue		
21	for damages sustained, and, if the judgment is for the		

- 1 plaintiff, the court shall award the plaintiff a sum not to
- 2 exceed the amount of these damages and reasonable attorney's
- 3 fees together with the cost of the suit.
- 4 (c) The lien holder and the registered owner shall have
- 5 ten days after receipt of the notice provided pursuant to
- 6 subsection (b) to request in writing an administrative hearing
- 7 pursuant to chapter 91 from the county police department that
- 8 caused the vehicle to be removed. The administrative hearing
- 9 shall be conducted for the sole purpose of allowing the lien
- 10 holder or registered owner of an impounded vehicle to contest
- 11 the basis given for the impoundment of the vehicle. The hearing
- 12 shall be held within five working days of the county police
- department's receipt of the written request.
- 14 [(c)] (d) When a vehicle is recovered by the owner or lien
- 15 holder before written notice is sent by registered or certified
- 16 mail, the towing company shall provide the owner or lien holder
- 17 with a receipt stating the maximum towing charges and fees
- 18 allowed by law and the telephone number of the county finance
- 19 department that arranged for or authorized the tow.
- 20 [(d)] (e) When a vehicle is not recovered within thirty
- 21 days after the mailing of the notice, it shall be deemed

the towing company's authorized representative, after one 2 statewide public notice as required in section 1-28.5, may 3 negotiate a sale of the vehicle or dispose of it as junk. 4 $[\frac{(e)}{(e)}]$ (f) The authorized seller of the vehicle shall be 5 entitled to the proceeds of the sale to the extent that 6 compensation is due the authorized seller for services rendered 7 in respect to the vehicle, including reasonable and customary 8 charges for towing, handling, storage, and the cost of the 9 notices and advertising required by this part. Any remaining 10 balance shall be forwarded to the registered owner or lien 11 holder of the vehicle if the registered owner or lien holder is 12 found. If the registered owner or lien holder cannot be found,

abandoned and the owner of the towing company, or the owner of

holder of the vehicle if a proper claim is filed therefor within 16

the balance shall be deposited with the director of finance of

the State and shall be paid out to the registered owner or lien

- one year from the execution of the sales agreement. 17
- holder shall have first priority to the funds to the extent of **18**

- [(f)] (g) The transfer of title and interest by sale under
 this section is a transfer by operation of law; provided that if
- 3 the certificate of ownership or registration is unavailable, a
- 4 bill of sale executed by an authorized seller is satisfactory
- 5 evidence authorizing the transfer of the title or interest.
- 6 [$\frac{(q)}{(q)}$] (h) This section shall not apply to a county that
- 7 has adopted ordinances regulating towing operations."
- 8 SECTION 3. This Act does not affect rights and duties that
- 9 matured, penalties that were incurred, and proceedings that were
- 10 begun before its effective date.
- 11 SECTION 4. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 5. This Act shall take effect upon its approval.
