A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 141, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part I to be appropriately
- 3 designated and to read as follows:
- 4 "§141- Fees; food safety certification activities;
- 5 prohibited. (a) Notwithstanding any other law to the contrary,
- 6 the department of agriculture shall not charge an agricultural
- 7 producer for the department's costs of conducting any and all
- 8 food safety certification activities under title 11.
- 9 (b) For the purposes of this section, the term
- 10 "agricultural producer" shall have the same meaning as in
- 11 section 155-5.6(d)."
- 12 SECTION 2. Section 141-12, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- "[+] \$141-12[+] Agricultural food safety certification
- 15 program. (a) There is established within the department of
- 16 agriculture an agricultural food safety certification program.

4	(b)	The chairperson of the board of agriculture may	
5	employ:

8		the FDA Food Safety Modernization Act to the program;

10	(2)	One clerical staff person.	
11	(c)	The program shall not charge any farmer or rancher for	
12	the depar	tment's costs of conducting any agricultural food

14	[(c)	[] (d) For purposes of this section, "agricultural	
15	food" includes food that is applicable to farmers and ranchers		
16	under the FDA Food Safety Modernization Act."		
17	SECTION 3. Section 159-32, Hawaii Revised Statutes, is		
18	amended to read as follows:		
19	"[+]§159-32[+] Reimbursement for inspection. The		
20	department may perform inspection of meat and meat products		
21	derived from exotic animals when requested by persons desiring		

- 1 [such] an inspection. Persons requesting and receiving
- 2 inspection service under this part shall [reimburse] not be
- 3 charged by the State for [all] the costs incurred by the State
- 4 in the provision of the service. [All such reimbursements shall
- 5 be deposited into the general fund.]"
- 6 SECTION 4. Section 159-46, Hawaii Revised Statutes, is
- 7 amended to read as follows:
- 8 "§159-46 Inspection; overtime compensation. (a) All
- 9 animals slaughtered by any slaughterhouse duly licensed under
- 10 this part shall be inspected by an inspector duly authorized by
- 11 the department, both before and after slaughtering, and no
- 12 animal shall be slaughtered, or after slaughter, be sold,
- 13 transported, offered for sale or transportation, or received for
- 14 transportation in commerce unless the slaughtering thereof or
- 15 the use thereof in commerce, after slaughtering, is approved by
- 16 an inspector.
- 17 (b) The management of any processing establishment $[\tau]$ or
- 18 slaughterhouse, or the owner of any animal to be slaughtered
- 19 requiring the services of an inspector in excess of eight
- 20 consecutive hours on any workday, or in excess of forty hours in
- 21 any workweek, or on legal holidays, shall [pay] not be liable to

- 1 the department for overtime inspection services [, the current
- 2 state overtime rate for each hour of work performed by the
- 3 inspector].
- 4 (c) The department shall pay the inspector for all
- 5 overtime inspection services performed; provided that the party
- 6 requesting or requiring the overtime inspection services shall,
- 7 sufficiently in advance of the overtime period, arrange with the
- 8 department for the services."
- 9 SECTION 5. Section 161-41, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "S161-41 Inspection; compensation. (a) All poultry
- 12 slaughtered by any slaughterhouse licensed under this part shall
- 13 be inspected by inspectors authorized by the department, both
- 14 before and after slaughtering, and no poultry shall be
- 15 slaughtered, or after slaughter, be sold, transported, offered
- 16 for sale or transportation, or received for transportation, in
- 17 intrastate commerce unless the slaughtering or the use after
- 18 slaughtering in intrastate commerce is approved by an inspector.
- 19 (b) The management of any processing establishment or
- 20 slaughterhouse, or the owner of any poultry to be slaughtered
- 21 requiring the services of an inspector in excess of eight

- 1 consecutive hours on any workday, or in excess of forty hours in
- 2 any workweek, or on legal holidays, shall [pay] not be liable to
- 3 the department for any overtime inspection services [the current
- 4 state overtime rate for each hour of work performed by the
- 5 inspector].
- 6 (c) The department shall pay the inspector, or inspectors,
- 7 for all overtime inspection services performed $[\tau]$; provided that
- 8 the party requesting or requiring the overtime inspection
- 9 services shall, sufficiently in advance of the overtime period,
- 10 arrange with the department for the services."
- 11 SECTION 6. This Act does not affect rights and duties that
- 12 matured, penalties that were incurred, and proceedings that were
- 13 begun before its effective date.
- 14 SECTION 7. Statutory material to be repealed is bracketed
- 15 and stricken. New statutory material is underscored.
- 16 SECTION 8. This Act shall take effect on July 31, 2150.
