#### A BILL FOR AN ACT

RELATING TO STATEWIDE INTEROPERABLE PUBLIC SAFETY COMMUNICATIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Oklahoma City
- 2 bombing, the attacks of September 11, 2001, Hurricane Katrina in
- 3 2005, and other subsequent terrorist and natural disasters, have
- 4 repeatedly exposed communication deficiencies faced by first
- 5 responders. This situation has negatively impacted the
- 6 nationwide goal of establishing robust and sustainable
- 7 interoperable public safety communications for emergency
- 8 responders at all levels of government.
- The legislature further finds that communication
- 10 deficiencies faced by first responders often result from
- 11 insufficient essential public safety communications personnel,
- 12 insufficient coordination and cooperation among agencies because
- 13 personnel are in disparate organizations or entities, inadequate
- 14 coordination in planning, insufficient policies and procedures,
- 15 incompatible and outdated communications equipment, inconsistent
- 16 or non-existent intra-agency or intra-entity coordination for

- 1 equipment and resources that are in multiple and disparate
- 2 locations, and funding limitations.
- 3 To deal with interoperable communications issues, Congress
- 4 passed Title XVIII of the Homeland Security Act of 2002, as
- 5 amended, which requires the United States Department of Homeland
- 6 Security, Office of Emergency Communications, to develop and
- 7 update a national emergency communications plan that identifies
- 8 capabilities and initiatives and sets strategic goals and
- 9 national objectives to ensure that emergency responders at all
- 10 levels of government and disciplines have interoperable
- 11 communications. To help states improve state and local
- 12 communications interoperability, homeland security grants for
- 13 communication interoperability initiatives require each state to
- 14 establish a statewide communication interoperability plan that
- 15 includes annual updates.
- 16 The legislature finds that as a matter of policy, all
- 17 efforts should be made to ensure that all county and state
- 18 public safety agencies have interoperable communications and
- 19 engage in coordinated planning, equipment purchases, and
- 20 infrastructure development. To achieve statewide
- 21 interoperability, all stakeholders must be involved in the



- 1 collaboration and development of shared objectives and
- 2 strategies.
- 3 The purpose of this Act is to establish a statewide
- 4 interoperability executive board that shall collaborate with all
- 5 levels of government to set statewide policy for statewide
- 6 interoperable public safety communications.
- 7 SECTION 2. Chapter 128A, Hawaii Revised Statutes, is
- 8 amended by adding a new part to be appropriately designated and
- 9 to read as follows:
- 10 "PART II. STATEWIDE PUBLIC SAFETY COMMUNICATIONS
- 11 INTEROPERABILITY
- 12 §128A- Statewide interoperability executive board. (a)
- 13 There is established within the department of defense for
- 14 administrative purposes the statewide interoperability executive
- 15 board, which shall be the primary steering group for public
- 16 safety interoperable communications statewide.
- 17 (b) The members of the statewide interoperability
- 18 executive board shall consist of the following members or the
- 19 member's designee:
- 20 (1) The adjutant general, who shall serve as the chair of
- 21 the board;
