A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Wasmannia
- 2 auropunctata, known as the little fire ant, threatens native
- 3 biodiversity, alters tropical ecosystems, impairs human health,
- 4 impedes tourism, diminishes agricultural productivity, mars
- 5 horticulture sales, and accordingly ranks among the world's
- 6 worst invasive species. Human behaviors and habitats allow the
- 7 little fire ant to move quickly, disperse widely, grow to high
- 8 densities, and inhabit locations not otherwise possible.
- 9 Hawaii's tropical climate is ideally suited for little fire
- 10 ant establishment and growth. The little fire ant, by far one
- 11 of Hawaii's worst invasive pests, is not only bothersome to
- 12 residents, visitors, and farmers because of its nasty sting, it
- 13 also harms agriculture and natural areas by nurturing other
- 14 invasive pests such as aphids, mealybugs, soft scale insects,
- 15 and whiteflies.
- 16 The legislature further finds that when compared to the
- 17 other counties, the county of Hawaii has been affected the most

- 1 by the little fire ant. The University of Hawaii, the county of
- 2 Hawaii, and the department of agriculture must collaborate to
- 3 develop and implement effective measures to address the impacts
- 4 of the little fire ant in the county of Hawaii.
- 5 The department of agriculture's little fire ant program was
- 6 created to survey, detect, and develop the most efficient little
- 7 fire ant management strategy with minimal impact to the State's
- 8 tropical ecosystem and non-target organisms, while serving as
- 9 the role model to eradicate the little fire ant in all
- 10 communities. The legislature finds that the department of
- 11 agriculture needs to be more proactive and aggressive in
- 12 implementing its current fire ant program.
- 13 The purpose of this Act is to establish a pilot pesticide
- 14 treatment coupon project within the department of agriculture's
- 15 existing little fire ant program, create a little fire ant site
- 16 map, and appropriate funds for these purposes.
- 17 SECTION 2. The department of agriculture shall establish
- 18 and implement a pilot pesticide treatment coupon project within
- 19 its current little fire ant program. The pilot project shall
- 20 distribute coupons redeemable for appropriate pesticides at
- 21 suppliers or vendors within the county of Hawaii at no cost to

- 1 individuals who have reported and verified to the department the
- 2 presence of little fire ants on their property within the county
- 3 of Hawaii. Each coupon shall be valid for a one-year supply of
- 4 the department's recommended treatment plan, including supplies
- 5 and equipment purchased from private companies; provided that
- 6 the value of the coupon shall not exceed the cost of a one-year
- 7 supply of the department's recommended treatment plan. The
- 8 department shall provide each individual with information on the
- 9 proper usage and health and safety precautions regarding the
- 10 department's recommended treatment plan.
- 11 SECTION 3. The department of agriculture shall create a
- 12 map that indicates all little fire ant sites in the county of
- 13 Hawaii by using all its available data, including verified
- 14 reports of little fire ant sites. The map shall be updated
- 15 monthly and made available on the department's website.
- 16 SECTION 4. The department of agriculture shall submit a
- 17 report on its progress in implementing the mandates of this Act
- 18 to the legislature no later than twenty days prior to the
- 19 convening of the regular session of 2018. The report shall
- 20 include findings and recommendations, including findings and
- 21 recommendations on whether the pilot project and little fire ant

- 1 site map should be continued, terminated, or modified. The
- 2 report shall also include any necessary proposed legislation.
- 3 SECTION 5. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$300,000 or so much
- 5 thereof as may be necessary for fiscal year 2017-2018 and the
- 6 same sum or so much thereof as may be necessary for fiscal year
- 7 2018-2019 for the little fire ant pilot pesticide treatment
- 8 coupon project established pursuant to section 2 and the little
- 9 fire ant site map established pursuant to section 3 of this Act.
- 10 The sums appropriated shall be expended by the department
- 11 of agriculture for the purposes of this Act.
- 12 SECTION 6. This Act shall take effect on July 1, 2017.
