A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Section 302A-706, Hawaii Revised Statutes, is
3	amended by amending its title and subsection (a) to read as
4	follows:
5	"§302A-706 [Teacher national board] National certification
6	incentive program. (a) There is established within the
7	department the [teacher] national [board] certification
8	incentive program to recognize and support exemplary [teaching]
9	educational practice by supporting public school teachers and
10	school psychologists who have achieved national [board]
11	certification under the certification program of the National
12	Board for Professional Teaching Standards[-] or the National
13	Association of School Psychologists. The [teacher] national
14	[board] certification incentive program shall provide:
15	(1) A \$5,000 bonus per year for each public school teacher
16	or school psychologist who maintains current national
17	[board] certification;

1	(2)	Up to \$1,500, depending on the certification fee
2		structure, upon completing all components of the
3		certification program of the National Board for
4		Professional Teaching Standards[+] or National
5		Association of School Psychologists;
6	(3)	A reimbursement of the remainder of the national
7		[board] certification application fee upon achievement
8		of national [board] certification; [and]
9	(4)	An additional \$5,000 bonus per year for each public
10		school teacher or school psychologist who maintains
11		current national [board] certification and who
12		[teaches] is employed at:

13	psychologist is no longer employed at the school,
14	whichever occurs first."

16	SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
17	amended by adding two new sections to be appropriately
18	designated and to read as follows:
19	"§302A-A Hawaii teacher stipend program. (a) There is
20	established the Hawaii teacher stipend program to be
21	administered by the department to address the shortfall of

1	licensed	teachers in the department's schools, especially in
2	identifie	d shortage areas.
3	(b)	A student is eligible for scholarship consideration if
4	the stude	nt:
5	(1)	Is enrolled at a University of Hawaii campus and
6		qualifies for Hawaii resident tuition; and
7	(2)	Is enrolled in a state approved teacher education
8		program at the University of Hawaii.
9	(c)	Stipend recipients shall teach in the Hawaii public
10	school sy	stem for three to five years immediately following
11	completio	n of a state approved teacher education program. If
12	the recip	ient fails to complete the state approved teacher
13	education	program, or to satisfy the teaching requirement within
14	the desig	nated number of years, stipend funds shall be repaid as
15	follows:	
16	(1)	For each year less than the designated number of years
17		that a stipend recipient does not teach in the Hawaii
18		public school system, the recipient shall repay a

2		stipend repayment, including circumstances under which
3		recipients may be eligible for deferment or
4		forgiveness due to hardship or inability to secure
5		employment.
6	(d)	The department may adopt rules pursuant to chapter 91
7	to implem	ent and administer the stipend program.
8	(e)	Moneys repaid by scholarship recipients pursuant to
9	subsectio	n (c) shall be deposited in the Hawaii teacher stipend
10	program s	pecial fund established under section 302A-B.
11	<u>§302</u>	A-B Hawaii teacher stipend program special fund. (a)
12	There is	established the Hawaii teacher stipend program special
13	fund, int	o which shall be deposited legislative appropriations
14	and all m	oneys received as repayment from students due to a

Expands the National Certification Incentive Program to provide monetary incentives to school psychologists. Authorizes continuing bonuses for teachers and school psychologists in certain designated schools that improve and no longer carry a certain designation. Establishes a Hawaii teacher stipend program to be administered by the Department of Education to address the shortage of teachers in the Hawaii public school system. Appropriates funds for the program for 2017-2018 and 2018-2019 fiscal years. Effective 7/1/2051. (SD2)
