## A BILL FOR AN ACT

RELATING TO DENTISTRY.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that Hawaii has a culture
2	of respecting medical professionals, including dentists, and
3	many consumers are reluctant to challenge the qualifications of
4	health care practitioners who hold themselves out to be licensed
5	and duly qualified. Furthermore, concerns about a health care
6	practitioner may arise once a consumer has begun receiving
7	treatment and the consumer may not know where to seek
8	information regarding the practitioner's licensing status or how
9	to access prior complaint history.
10	The legislature further finds that the administration of
11	general anesthesia, deep sedation, or moderate (conscious)
12	sedation during routine dental procedures is a matter that
13	requires greater oversight than is currently required. While
14	the administration of such drugs can be done safely as part of a
15	routine dental procedure, it is important that the facilities,
16	equipment, and staffing of a dental practice that administers
17	these drugs are adequately equipped to respond to a patient who

- 1 may experience medical complications during a procedure. Safety
- 2 of patients is always of paramount concern, but is especially
- 3 important when the patients involved are small children, whose
- 4 age and size render them especially vulnerable to large doses of
- 5 anesthesia or sedatives.
- 6 The legislature additionally finds that if better standards
- 7 had been in place, the tragic death of three-year old dental
- 8 patient Finley Boyle could have been prevented. In December of
- 9 2013, Finley went to a dentist in Kailua and received the
- 10 maximum dose of five different sedative drugs. Subsequently,
- 11 she stopped breathing and suffered a heart attack and brain
- 12 damage. She died in hospice a few weeks later. The dentist in
- 13 question lacked any formal training in administering oral
- 14 sedatives to a child, but advertised her dental practice as
- 15 being one "for children".
- 16 The legislature notes that the current administrative rules
- 17 of the board of dental examiners authorize the board to conduct
- 18 an inspection and evaluation of the facilities, equipment, and
- 19 personnel of those applying for a written authorization or
- 20 permit to administer general anesthesia, deep sedation, or

1 moderate (conscious) sedation, but the rules do not make such

2 inspections mandatory.

3 The purpose of this Act is to:

- 4 (1) Require that every dental office in which general 5 anesthesia, deep sedation, or moderate (conscious) 6 sedation is administered display and keep in a 7 conspicuous place a notice containing contact 8 information for the consumer resource center of the 9 department of commerce and consumer affairs' regulated **10** industries complaints office, so that consumers can 11 verify that the dentist is licensed and holds a 12 current and valid written authorization or permit to 13 administer anesthesia or perform sedation, request 14 prior complaint history on a dentist or dental 15 licensee, or file a complaint against a dentist or 16 dental licensee, and that information on the special **17** privilege accorded to a dentist to administer 18 anesthesia or sedation is reported by the consumer 19 resource center upon request;
- (2) Specify the requirements a licensed dentist must meet
  to administer general anesthesia, deep sedation, or

1		moderate (conscious) sedation, including the
2		requirements that must be met prior to receiving a
3		written authorization or permit for the administration
4		of anesthesia or sedation; and
5	(3)	Require the board of dental examiners to perform an
6		on-site inspection of the facility, equipment, and
7		personnel of a licensed dentist prior to the issuance
8		or renewal of a written authorization or permit to
9		administer general anesthesia, deep sedation, or
10		moderate (conscious) sedation, including a requirement
11		that a licensed dentist show proof of the dentist's
12		written authorization or permit and resuscitation
13		plan.
14	SECT	ION 2. Chapter 448, Hawaii Revised Statutes, is
15	amended by	y adding three new sections to be appropriately
16	designate	d and to read as follows:
17	" <u>§44</u>	8-A Notice to consumers. Every dentist who:
18	(1)	Is engaged in the practice of dentistry; and
19	(2)	Administers general anesthesia, deep sedation, or
20		moderate (conscious) sedation,

- 1 shall display and keep in a conspicuous place at the dentist's
- 2 place of business a notice no smaller than eight and one-half
- 3 inches by eleven inches. The notice shall explain that any
- 4 person may contact the consumer resource center of the
- 5 department of commerce and consumer affairs' regulated
- 6 industries complaints office to verify that the dentist is
- 7 licensed and holds a current and valid written authorization or
- 8 permit to administer anesthesia or perform sedation, request
- 9 prior complaint history on a dentist, or file a complaint
- 10 against a dentist, and that information on the special privilege
- 11 accorded to a dentist to administer general anesthesia, deep
- 12 sedation, or moderate (conscious) sedation is reported by the
- 13 consumer resource center upon request. The notice shall include
- 14 all available contact information for the consumer resource
- 15 center, including a telephone number. The text of all
- 16 information contained in the notice shall be in a font size no
- 17 smaller than one-half inch. A dentist who fails to ensure the
- 18 continuous display of such a notice shall be subject to the
- 19 penalties provided in this chapter.
- 20 §448-B Administration of general anesthesia and sedation;
- 21 requirements. (a) A licensed dentist shall administer general

- 1 anesthesia and sedation consistent with the current guidelines
- 2 and recommendations of the American Dental Association
- 3 Guidelines for the Use Of Sedation and General Anesthesia by
- 4 Dentists; provided that for pediatric patients, a licensed
- 5 dentist shall follow the American Academy of Pediatrics and
- 6 American Academy of Pediatric Dentistry Guidelines for
- 7 Monitoring and Management of Pediatric Patients During and After
- 8 Sedation for Diagnostic and Therapeutic Procedures.
- 9 (b) No licensed dentist shall administer or employ another
- 10 person, such as a physician or nurse anesthetist, who is
- 11 otherwise qualified in this State to administer general
- 12 anesthesia, deep sedation, or moderate (conscious) sedation for
- 13 dental patients, unless the licensed dentist possesses a written
- 14 authorization or permit from the board.
- 15 (c) A licensed dentist intending to produce a given level
- 16 of sedation shall have the capability to rescue patients whose
- 17 level of sedation becomes deeper than initially intended.
- 18 (d) Prior to receiving a written authorization or permit
- 19 from the board to administer general anesthesia, deep sedation,
- 20 or moderate (conscious) sedation, a licensed dentist shall apply
- 21 to the board, pay an application fee, and submit the following:

1	<u>(1)</u>	Proof of	completion of the following educational
2		training	requirements:
3		(A) For	general anesthesia and deep sedation:
4		<u>(i)</u>	The applicant has completed an advanced
5			dental education program, accredited by the
6			Commission on Dental Accreditation and
7			approved by the board, that provides
8			comprehensive training necessary to
9			administer deep sedation or general
10			anesthesia and includes documented
11			proficiency in Basic Life Support for
12			Healthcare Providers and Advanced Cardiac
13			Life Support or Pediatric Advanced Life
14			Support as required pursuant to rules
15			adopted by the board; and
16		<u>(ii)</u>	Evidence of the comprehensive training
17			required under clause (i) includes but is
18			not limited to: being a diplomate of the
19			American Board of Oral and Maxillofacial
20			Surgery; a fellow or member of the American
21			Association of Oral and Maxillofacial

1		Surgeons; or completion of an American
2		Dental Association-accredited residency in
3		Oral and Maxillofacial Surgery or Dental
4		Anesthesiology, and practicing in compliance
5		with that training;
6	(B) For	moderate (conscious) sedation:
7	<u>(i)</u>	The applicant has completed a comprehensive
8		training program at the postgraduate level
9		that meets the moderate (conscious) sedation
10		program objectives and content as outlined
11		in the current American Dental Association
12		Guidelines for Teaching Pain Control and
13		Sedation to Dentists and Dental Students;
14		and
15	<u>(ii)</u>	The training program required under clause
16		(i) shall be a minimum of sixty hours of
17		instruction, include supervised management
18		of at least twenty moderate (conscious)
19		sedation patients with clinical experience
20		in managing the compromised airway and
21		establishment of intravenous access, and

1		provide current documented proficiency in
2		Basic Life Support for Healthcare Providers
3		and Advanced Cardiac Life Support or
4		Pediatric Advanced Life Support as required
5		pursuant to rules adopted by the board; and
6		(C) A dentist administering general anesthesia or
7		moderate sedation shall be required to complete
8		the Advanced Cardiac Life Support course or, if
9		treating pediatric patients, the Pediatric
10		Advanced Life Support course; provided that both
11		courses shall be completed if the dentist is
12		treating pediatric patients and minors thirteen
13		years or older;
14	(2)	In lieu of the requirements of paragraph (1)(A) and
15		(B), proof that the licensed dentist employs or works
16		in conjunction with a physician who specializes in
17		anesthesiology and is licensed pursuant to chapter
18		453, or a certified registered nurse anesthetist, who
19		holds a license in good standing pursuant to chapter
20		457; provided that the physician who specializes in
21		anesthesiology or certified registered nurse

1		anesthetist shall remain on the premises of the dental
2		facility until the patient is fully recovered and
3		discharged from the facility; and
4	(3)	Proof of the following facility and staff
5		requirements: The applicant has a properly equipped
6		facility for the administration of general anesthesia,
7		deep sedation, or moderate (conscious) sedation
8		staffed with a supervised team of auxiliary personnel
9		capable of reasonably handling anesthesia procedures,
10		problems, and emergencies incident to the
11		administration of general anesthesia, deep sedation,
12		or moderate (conscious) sedation; provided that the
13		current version of the American Dental Association's
14		Guidelines for the Use of Sedation and General
15		Anesthesia by Dentists and the most current edition of
16		the American Association of Oral and Maxillofacial
17		Surgeons' Office Anesthesia Evaluation Manual are
18		referenced as minimum standards of care; provided
19		further that adequacy of the facility and competence
20		of the anesthesia team may be determined by the

1	consultants appointed by the board as provided in
2	rules adopted by the board.
3	(e) A licensed dentist who has received a written
4	authorization or permit pursuant to this section to administer
5	or employ a qualified person to administer general anesthesia,
6	deep sedation, or moderate (conscious) sedation shall renew the
7	authorization or permit biennially and pay a biennial fee. As a
8	condition of renewal, the licensed dentist shall show proof of
9,	the dentist's written authorization or permit issued pursuant to
10	this section and resuscitation plan.
11	(f) The board may, at any time, reevaluate the
12	credentials, facilities, equipment, personnel, and procedures of
13	a licensed dentist who has previously received a written
14	authorization or permit from the board to determine if the
15	dentist is still qualified to have a written authorization or
16	permit. If the board determines that the licensed dentist is no
17	longer qualified to have a written authorization or permit, it
18	may revoke or refuse to renew the authorization or permit, after
19	an opportunity for a hearing is given to the licensed dentist.
20	§448-C Inspection of facilities, equipment, and personnel.
21	(a) Prior to the issuance or renewal of a written authorization

- 1 or permit pursuant to section 448-B, the board shall, in
- 2 addition to other requirements established by statute or
- 3 administrative rule, require an on-site inspection of the
- 4 facility, equipment, and personnel to determine whether the
- 5 facility and staff requirements pursuant to section 448-B(d)
- 6 have been met. The inspection to determine whether the facility
- 7 is adequate and properly equipped may be carried out in a manner
- 8 that generally follows the guidelines, standards, requirements,
- 9 and basic principles as described in the most current edition of
- 10 the American Association of Oral and Maxillofacial Surgeons'
- 11 Office Anesthesia Evaluation Manual. The inspection and
- 12 evaluation shall be carried out by a team of consultants
- 13 appointed by the board.
- 14 (b) Written authorizations and permits subject to section
- 15 448-B shall be issued only to those applicants whose facilities,
- 16 equipment, and personnel have been deemed adequate pursuant to
- 17 this section."
- 18 SECTION 3. No later than July 1, 2018, the board of dental
- 19 examiners shall adopt rules, pursuant to chapter 91, Hawaii
- 20 Revised Statutes, to effectuate the purposes of this Act.

- 1 SECTION 4. In codifying the new sections added by section
- 2 of this Act, the revisor of statutes shall substitute
- 3 appropriate section numbers for the letters used in designating
- 4 the new sections in this Act.
- 5 SECTION 5. New statutory material is underscored.
- 6 SECTION 6. This Act shall take effect on July 1, 2090.

#### Report Title:

Dentistry; Consumer Information; Patient Safety; Anesthesia; Sedation; Inspections; "Finley's Law"

#### Description:

Requires dentists who administer general anesthesia, deep sedation, or moderate (conscious) sedation to post notice of contact information for verification of the dentist's licensure, and authorization and permit, to administer anesthesia and sedation. Specifies requirements a licensed dentist must meet in order to administer anesthesia or sedation, including requirements that must be met prior to receiving a written authorization or permit for the administration of anesthesia or sedation. Requires inspection of a dentist's facilities, equipment, and personnel prior to the issuance or renewal of a written authorization or permit to administer anesthesia or sedation. Effective 7/1/2090.
