## A BILL FOR AN ACT

RELATING TO SOCIAL AND EMOTIONAL LEARNING.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that all students need to  
2 learn social and emotional skills that encourage peaceful  
3 resolution of disputes and enable them to fully participate in  
4 the educational process free from bullying and cyberbullying. A  
5 safe and civil environment in school is necessary for students  
6 to learn and to meet high academic standards. Bullying and  
7 cyberbullying, like other disruptive or violent behaviors,  
8 inhibit a student's ability to learn and a school's ability to  
9 educate students in a safe environment. It is imperative that  
10 all public schools and public charter schools and youth-serving  
11 agencies in the State receive training to encourage positive  
12 behavior and prevent bullying, harassment, and discrimination.  
13 Training school personnel and other persons serving students to  
14 support social and emotional learning will enable school  
15 administrators, faculty, staff, parents, guardians, and  
16 volunteers to be an example for students by demonstrating



1 appropriate behavior, treating others with civility and respect,  
2 and refusing to tolerate bullying and harassment.

3 The purpose of this Act is to:

- 4 (1) Require the department of education to provide  
5 training on social and emotional learning to all  
6 youth-serving educators, health care professionals and  
7 counselors, and agencies and programs, as well as  
8 parents of students enrolled in a public school or  
9 public charter school using evidence-based and  
10 evidence-informed curricula and materials that are  
11 scientifically accurate, age appropriate, and  
12 culturally relevant; and
- 13 (2) Appropriate funds to the department of education to  
14 conduct training on social and emotional learning to  
15 all youth-serving educators, health care professionals  
16 and counselors, and agencies and programs to encourage  
17 positive social behaviors and protect youth in the  
18 State from all forms of bullying and cyberbullying.

19 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is  
20 amended by adding a new section to be appropriately designated  
21 and to read as follows:



1           "§302A-       Social and emotional learning; training. (a)

2   The department shall provide training on social and emotional  
3   learning to any of the following persons, as determined by the  
4   department:

- 5           (1) Teachers of school age children;
- 6           (2) Health care professionals or counselors serving school  
7           age children;
- 8           (3) Parents of school age children; and
- 9           (4) Any agencies or programs, including agencies or  
10           programs receiving grants or purchases of service,  
11           pursuant to chapters 42F or 103F, respectively, that  
12           provide services to school age children;

13   provided that this section shall apply to youth-serving  
14   educators, health care professionals and counselors, and  
15   agencies and programs, as well as parents of students enrolled  
16   in public schools subject to this chapter or public charter  
17   schools subject to chapter 302D.

18           (b) Any funds received by the department for training on  
19   social and emotional learning shall be used for new or existing  
20   training programs, including those that are designed to prevent

1 bullying and harassment, and shall not supplant any other funds  
2 previously allocated to these programs.

3 (c) The department shall adopt rules in accordance with  
4 chapter 91 to carry out the purposes of this section, including  
5 but not limited to:

6 (1) Identifying the types of programs and opportunities  
7 available for training on social and emotional  
8 learning;

9 (2) Establishing a program on training on social and  
10 emotional learning that is evidence-based and  
11 evidence-informed curricula and materials that are  
12 scientifically accurate, age appropriate, and  
13 culturally relevant; and

14 (3) Determining the persons who shall receive training on  
15 social and emotional learning pursuant to this  
16 section."

17 SECTION 3. Chapter 302D, Hawaii Revised Statutes, is  
18 amended by adding a new section to be appropriately designated  
19 and to read as follows:

**Report Title:**
