### A BILL FOR AN ACT

RELATING TO CANCER.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that "80% by 2018" is an
2	initiative by the National Colorectal Cancer Roundtable, a
3	working group established by the United States Centers for
4	Disease Control and Prevention and other national cancer control
5	stakeholders, in which organizations have committed to
6	eliminating colorectal cancer as a major public health problem
7	and are working toward the shared goal of getting eighty per
8	cent of adults aged fifty and older screened for colorectal
9	cancer by 2018.
10	The "80% by 2018" initiative is vital to reducing the
11	burden of cancer because:
12	(1) Colorectal cancer is the third leading cause of cancer
13	death in men and women in the United States, and a
14	cause of considerable suffering among more than one
15	hundred forty thousand adults diagnosed with
16	colorectal cancer each year;

6	(3)	About twenty-three million people, which is about one
7		in three adults between fifty and seventy-five years
8		old, are not getting tested as recommended;
9	(4)	The people less likely to get tested are rural

13		including colonoscopy, stool tests such as a guaiac

- 2 states ranks in the bottom half, indicating there is more work
- 3 to be done to increase colorectal cancer screening rates.
- 4 The legislature also finds that the "80% by 2018"
- 5 initiative's goal of increasing the colorectal cancer screening
- 6 rate to eighty per cent by 2018 will increase the quality of
- 7 life for hundreds of people in the State by detecting and
- 8 preventing death from late stage colorectal cancer and lessening
- 9 the physical, emotional, and financial burden that may come with
- 10 a cancer diagnosis.
- 11 The purpose of this Act is to launch a colorectal cancer
- 12 screening and awareness pilot program to promote and encourage
- 13 screening through a public awareness campaign to help the State
- 14 achieve an increase in screening rates in conjunction with the
- 15 "80% by 2018" initiative.
- 16 SECTION 2. (a) There is established the colorectal cancer
- 17 screening and awareness pilot program, to be administered by the
- 18 department of health. The department of health shall:
- 19 (1) Provide education and outreach to:

1		(A)	Educate women and men regarding the risks
2			associated with colorectal cancer and the
3			benefits of screening; and
4		(B)	Provide specific education to individuals who are
5			at greater risk for colorectal cancer; and
6	(2)	Awar	d grants to health care providers to provide
7		colo	rectal cancer screening to eligible participants,
8		as d	escribed in subsection (b).
9	(b)	To b	e an eligible participant to receive screening
10	assistanc	e pur	suant to subsection (a)(2), a person shall:
11	(1)	Be a	t least fifty years of age, or have a high risk
12		for	colorectal cancer if under the age of fifty;
13	(2)	Be u	ninsured, or if underinsured have coverage that
14		does	not cover the full cost of colorectal cancer
15		scre	enings;
16	(3)	Not	be eligible for medical assistance; and
17	(4)	Have	a gross family income at or below two hundred
18		fift	y per cent of the poverty level.
19	(c)	Any	eligible participant who is:
20	(1)	Not	at high risk for colorectal cancer may be offered
21		any	fecal test assigned a grade of either A or B by

1		the United States Preventive Services Task Force and a
2		follow-up colonoscopy for a positive test result; and
3	(2)	At high risk for colorectal cancer shall be provided a
4		colonoscopy as a first-line screening;
5	provided	that grants awarded to health care providers under the
6	colorecta	l cancer screening and awareness pilot program shall
7	pay the c	osts for a colonoscopy for eligible participants who
8	lack insu	rance coverage for the full cost of the follow-up
9	colonosco	py or first-line screening colonoscopy.
10	(d)	For purposes of this section, an eligible participant
11	is consid	ered "high risk for colorectal cancer" if the person
12	has:	
13	(1)	A family history of colorectal cancer;
14	(2)	A prior occurrence of cancer or precursor neoplastic
15		polyps;
16	(3)	A prior occurrence of a chronic digestive disease
17		condition; or
18	(4)	Other predisposing factors, as determined by the
19		department of health.
20	(e)	The department of health shall submit to the

1	(1)	A preliminary report no later than twenty days prior		
2		to the convening of the regular session of 2018 on the		
3		expenditure of funds for the colorectal cancer		
4		screening and awareness pilot program as of the date		
5		of the preliminary report; and		
6	(2)	A final report no later than twenty days prior to the		
7		convening of the regular session of 2020 on the		
8		expenditure of all funds for the colorectal cancer		
9		screening and awareness pilot program as of the date		
10		of the final report.		
11	SECT	ION 3. There is appropriated out of the general		
12	revenues	of the State of Hawaii the sum of \$250,000 or so much		
13	thereof a	s may be necessary for fiscal year 2017-2018 and the		
14	same sum or so much thereof as may be necessary for fiscal year			
15	2018-2019	for the colorectal cancer screening and awareness		
16	pilot pro	gram established pursuant to this Act.		
17	The	sums appropriated shall be expended by the department		
18	of health	for the purposes of this Act.
