A BILL FOR AN ACT

RELATING TO THE STATE BUILDING CODES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. For centuries, Hawaii has been blessed with
 consistent rainfall and, due to its geology, with high-quality
 fresh water. Recently, however, scientists, farmers, and others
 have observed signs that threaten the long-term fresh water
 security of the Hawaiian islands.

6 The Pacific Islands Regional Climate Assessment reports
7 that throughout the Pacific region, warmer and drier conditions
8 will result in drought and rising temperatures, thus causing a
9 decrease of fresh water supplies.

Hawaii needs to make changes that will increase its ability to capture, store, and efficiently use fresh water. Among the least expensive and most efficient ways to increase the supply of fresh water are water conservation and reuse. An important component in the conservation and reuse of water is the timely adoption, through amendments to the state building codes, of changes to the model Uniform Plumbing Code that encourage water

1 resource conservation, improvements to water distribution 2 systems, and recovery of used water. 3 The purpose of this Act is to expedite the review, 4 updating, and adoption of appropriate updates to the Uniform 5 Plumbing Code, through amendments to the state building codes. 6 SECTION 2. Section 107-24, Hawaii Revised Statutes, is 7 amended by amending subsection (f) to read as follows: The council shall review and adopt, as appropriate, 8 "(f) new model building codes within eighteen months of the official 9 10 publication date [-]; provided that the council shall review and 11 adopt the necessary and desirable amendments to the Uniform Plumbing Code within after the updated Uniform 12 13 Plumbing Code is published by the International Association of 14 Plumbing and Mechanical Officials." 15 SECTION 3. Section 107-28, Hawaii Revised Statutes, is amended to read as follows: 16 "§107-28 County authority to amend and adopt the Hawaii 17 state building codes without council approval. (a) 18 The 19 governing body of each county shall amend, adopt, and update the 20 Hawaii state building codes as they apply within their 21 respective jurisdiction, in accordance with section 46-1.5(13),

without approval of the council. Each county shall amend and 1 2 adopt the Hawaii state building codes and standards listed in 3 section 107-25, as the referenced Hawaii state building codes and standards for its respective county building code ordinance, 4 5 no later than two years after the adoption of the Hawaii state 6 building codes [-]; provided that each county shall adopt the 7 necessary and desirable amendments to the Uniform Plumbing Code specified in section 107-25(2), within after the 8 9 updated Uniform Plumbing Code is adopted by the council. If a county does not amend the Hawaii state building 10 (b) codes within the two-year time frame $[\tau]$ for codes specified in 11 12 section 107-25(1), (3), and (4), or the time frame for the code specified in section 107-25(2), the Hawaii state 13 14 building codes shall become applicable as an interim county 15 building code." SECTION 4. There is appropriated out of the general 16

17 revenues of the State of Hawaii the sum of \$ or so
18 much thereof as may be necessary for fiscal year 2017-2018 and
19 the same sum or so much thereof as may be necessary for fiscal
20 year 2018-2019 for the state building code council to carry out
21 its duties including the hiring of necessary staff.
