A BILL FOR AN ACT

RELATING TO THE WEED AND SEED STRATEGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The weed and seed strategy is a United States 2 Department of Justice initiative that is administered locally by 3 the United States Attorney's Office. Initiated in 1992, the 4 strategy currently includes more than three hundred sites in two 5 hundred twenty-six cities across the country. 6 The weed and seed strategy is a collaborative effort among 7 federal, state, and county level law enforcement agencies, 8 social service agencies, private businesses, nonprofit 9 organizations, and residents to reclaim, restore, and rebuild 10 communities. The four key elements of the weed and seed 11 strategy are: (1) Law enforcement; (2) Community policing;

- 14 (3) Prevention, intervention, and treatment programs; and

- 1 activity in targeted neighborhoods by "weeding" out the criminal
- 2 element in the community. Community policing involves having
- 3 police officers work closely with community residents to develop
- 4 solutions to violent and drug-related crimes. The next step is
- 5 to "seed" the community with human services that include
- 6 prevention, intervention, treatment, and neighborhood
- 7 revitalization.
- 8 The legislature finds that the weed and seed strategy has
- 9 been successful since its inception in the Kalihi-Palama and
- 10 Chinatown areas of downtown Honolulu. The legislature also
- 11 finds that, since the beginning of the program, crime in those
- 12 areas has been significantly reduced. The legislature further
- 13 finds that the strategy's success warrants its expansion into
- 14 other communities.
- 15 The purpose of this Act is to make an appropriation to
- 16 maintain and expand the weed and seed strategy.
- 17 SECTION 2. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$ or so much
- 19 thereof as may be necessary for fiscal year 2017-2018 as a
- 20 grant-in-aid to the city and county of Honolulu office of the

- 1 prosecuting attorney to maintain and expand the weed and seed
- 2 strategy.
- 3 The sum appropriated shall be expended by the department of
- 4 the attorney general for the purposes of this Act.
- 5 SECTION 3. This Act shall take effect on July 1, 2050.
