MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

7	with the exclusive bargaining representatives of collective		
8	bargaining unit (10):
