(a) "§353H-5 The department, in collaboration with the department of 6 transportation and the examiner of drivers of each county, shall 7 inform inmates that departmental assistance is available to obtain civil identification cards, in accordance with part XVI 8 9 of chapter 286, and upon request shall issue civil 10 identification cards to inmates who have one year or less prior 11 to the inmate's parole or release date remaining on their prison 12 sentence. 13 (b) The department, in collaboration with appropriate 14 federal, state, and county agencies, shall inform inmates of the 15 availability of departmental assistance to obtain the inmate's 16 birth certificate, social security card, and any other relevant 17 identification documents necessary for the inmate to transition
