BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is

- 1 performances; the sale of goods produced by or for department

- 5 §302A-C Service mark registration. The department may
- 6 register with the department of commerce and consumer affairs
- 7 any service mark of the department or an individual department
- 8 school.
- 9 §302A-D Rules. The department shall adopt rules pursuant
- 10 to chapter 91 for the purposes of this part. Rules adopted
- 11 pursuant to this section shall address, at minimum:
- 12 (1) An application process for a service mark licensing
- 13 agreement;
- 14 (2) Standards for potential licensees and selection
- 15 criteria;
- 16 (3) The appropriateness and quality of proposed licensed
- 17 products and uses;
- 18 (4) The assessment and collection of fees;
- 19 (5) The disposition of fees and royalties;
- 20 (6) An appeals process for an application for a service
- 21 mark licensing agreement that has been denied; and

3	SECTION 2. In codifying the new sections added by section
4	1 of this Act, the revisor of statutes shall substitute
5	appropriate section numbers for the letters used in designating
6	the new sections in this Act.
7	SECTION 3. This Act does not affect rights and duties that
8	matured, penalties that were incurred, and proceedings that were
9	begun, before the effective date of this Act.
10	SECTION 4. This Act shall take effect upon its approval.
