A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . MARK LICENSING AGREEMENT PROGRAM
- 5 §302A-A Definitions. As used in this part, "mark" means
- 6 any trademark or service mark entitled to registration under
- 7 chapter 482, whether registered or not.
- 8 §302A-B Mark licensing agreement program; established.
- 9 (a) There is established within the department a mark licensing
- 10 agreement program to allow the department and a department
- 11 school to license, as applicable, the department's or department
- 12 school's marks.
- 13 (b) The department may enter into licensing agreements
- 14 pursuant to this part and any rules adopted pursuant to section
- 15 302A-E.
- 16 §302A-C Commercial enterprises. Notwithstanding any law
- 17 to the contrary, the department may engage in commercial



- 1 enterprises that are related and incidental to the primary
- 2 purposes of the department as set forth in this chapter,
- 3 including the sponsorship of private, cultural, and athletic
- 4 performances; the sale of goods produced by or for department
 - 5 programs or an individual department school; or the production
- 6 of goods bearing a department or an individual department school
- 7 mark.
- 8 §302A-D Mark registration. The department may register
- 9 with the department of commerce and consumer affairs any mark of
- 10 the department or an individual department school.
- 11 §302A-E Administrative rules. The department shall adopt
- 12 rules pursuant to chapter 91 for the purposes of this part.
- 13 Rules adopted pursuant to this section shall address, at
- 14 minimum:
- 15 (1) An application process for a mark licensing agreement;
- 16 (2) Standards for potential licensees and selection
- 17 criteria;
- 18 (3) The appropriateness and quality of proposed licensed
- 19 products and uses;
- 20 (4) The assessment and collection of fees;
- 21 (5) The disposition of fees and royalties;

- 1 (6) An appeals process for an application for mark
- 2 licensing that is denied; and
- 3 (7) A process to revoke or suspend a mark licensing
- 4 agreement."
- 5 SECTION 2. In codifying the new sections added by section
- 6 1 of this Act, the revisor of statutes shall substitute
- 7 appropriate section numbers for the letters used in designating
- 8 the new sections in this Act.
- 9 SECTION 3. This Act does not affect rights and duties that
- 10 matured, penalties that were incurred, and proceedings that were
- 11 begun, before the effective date of this Act.
- 12 SECTION 4. This Act shall take effect on July 1, 2051.
