A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. The legislature finds that it is a matter of |

| 14 | §304A- Center for commercialization; establishment. |
| 15 | (a) There is established, within the office of the vice |
| 16 | president for research and innovation, a center for |
| 17 | commercialization. The center shall be dedicated to fostering |

1 an environment conducive to commercializing the intellectual 2 property created by basic and applied research at the University 3 of Hawaii for the benefit of the public and the State. 4 There shall be a director, appointed by the vice (b) 5 president for research and innovation, who shall direct the 6 activities of the center for commercialization." 7 SECTION 3. The director of the center for 8 commercialization shall submit annual reports of findings and 9 recommendations, including any proposed legislation, regarding 10 the activities of and plans for the center for commercialization 11 to the legislature no less than twenty days prior to the 12 convening of each regular session, commencing with the regular 13 session of 2018 and ending with the regular session of 2021. 14 The report, shall, among other things, identify and discuss: 15 (1)Currently existing resources and facilities at the 16 University of Hawaii or any other state agency, 17 including any applicable regulatory framework or 18 programs, that may be used, consolidated, or 19 incorporated into the center for commercialization; 20 (2) Policies, goals, mission statements, and guidelines for the center for commercialization; 21
