A BILL FOR AN ACT

RELATING TO HIGH OCCUPANCY VEHICLE LANES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 291C-222, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§291C-222 Designation of high occupancy vehicle lane.
- 4 (a) The director of transportation by rules adopted in
- 5 accordance with chapter 91, and the counties by ordinance, may
- 6 designate high occupancy vehicle lanes as to roadways under
- 7 their respective jurisdictions.
- **8** (b) Signs and other official traffic-control devices that
- 9 designate high occupancy vehicle lanes shall be placed and
- 10 maintained to advise drivers of the high occupancy vehicle
- 11 requirement and the hours of usage. When the high occupancy
- 12 vehicle lane also serves as a contraflow lane, the hours of
- 13 usage as a high occupancy vehicle lane shall be the time when
- 14 the lane is coned for use as a high occupancy vehicle lane.
- 15 (c) No motor vehicle shall be operated upon these lanes
- 16 except in conformance with the instructions on the signs and
- 17 other official traffic-control devices.

- 1 (d) A motorcycle may use any high occupancy vehicle lane,
- 2 regardless of the number of occupants.
- 3 (e) Any vehicle authorized by rules adopted in accordance
- 4 with chapter 91 may use any high occupancy vehicle lane,
- 5 regardless of the number of occupants, when the use is
- 6 determined to enhance public safety and improves traffic
- 7 conditions.
- 8 (f) Notwithstanding any other penalty established in this
- 9 part, any person who violates subsection (c) shall be deemed to
- 10 have committed a traffic infraction, as defined in section
- 11 291D-2, and shall be subject to a fine of \$150 that shall be
- 12 deposited into the state highway fund."
- 13 SECTION 2. Section 291C-227, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "§291C-227 Penalty. A person who violates any provision
- 16 of this part shall for a first conviction thereof be fined \$75;
- 17 for conviction of a second offense committed within one year
- 18 after the date of the first offense, the person shall be fined
- 19 \$150; for conviction of a third or subsequent offense committed
- 20 within one year after the date of the first offense, the person
- 21 shall be fined \$200[-]; provided that a person who violates

- 1 section 291C-222(c) shall be subject to the penalty specified in
- 2 that section."
- 3 SECTION 3. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect on July 1, 2050.
