HOUSE CONCURRENT RESOLUTION

REQUESTING THE OFFICE OF ELECTIONS TO CONVENE A TASK FORCE ON AUTOMATIC VOTER REGISTRATION.

1	WHEREAS, Hawaii's voter turnout percentage has
2	significantly declined since statehood in 1959, when turnout
3	stood at ninety-four percent of registered voters; and
4	
5	WHEREAS, the percentage of registered voters in Hawaii who
6	turn out to vote now ranks among the lowest of the fifty states;
7	and
8	
9	WHEREAS, voter participation is the hallmark of an
10	effective democracy; and
11	WIEDERC on improved process of outomotic reter
12 13	WHEREAS, an improved process of automatic voter registration would be beneficial to the public and reduce any
13 14	inconvenience currently experienced; and
14	inconvenience currenciy experienced, and
16	WHEREAS, the Legislature believes that an automatic voter
17	registration process would increase accuracy and efficiency; and

19	WHEREAS, removing barriers to registration for eligible
20	voters is the first step to increasing voter participation; and
21	
22	WHEREAS, automatic voter registration would provide
23	eligible voters with the opportunity to register to vote when
24	applying for or renewing a driver's license or state
25	identification card unless the eligible voter affirmatively
26	declines to be registered; and
27	
28	WHEREAS, voter registration through a routine and necessary
29	transaction, such as driver's licensing or renewal, increases

voter registration efficiency and effectiveness and voter 1 2 turnout; and 3 4 WHEREAS, automatic voter registration utilizes information 5 that the government has already collected; and 6 7 WHEREAS, current federal laws authorize the electronic 8 transfer of voter registration information from the counties and 9 Department of Transportation to election officials and the 10 statewide voter registration system; and 11 12 WHEREAS, nothing in the transfer of data would interfere with any election official's authority or obligation, under 13 state or federal law; and 14 15 WHEREAS, six states and the District of Columbia have 16 already successfully enacted automatic voter registration 17 systems; and 18 19 20 WHEREAS, in 2016, Oregon implemented an automatic voter registration system, and more than 270,000 eligible voters 21 22 registered via the system, forty three percent of whom voted in the 2016 general election, thus helping Oregon set a new state 23 record for the number of votes cast; and 24 25 26 WHEREAS, automatic voter registration increases security 27 and results in improved accuracy of voter rolls through the use of an encrypted system to transfer data rather than using paper 28 29 forms; and 30 WHEREAS, automatic voter registration would produce long-31 term cost savings for the State, since processing paper voter 32 33 registration forms costs almost thirty times more than using 34 electronic registration; and 35 36 WHEREAS, innovative efforts have been undertaken in other states to successfully reduce barriers to voting, encourage 37 voter participation, and make voting more convenient; now, 38 39 therefore; now, therefore, 40

6 7	BE IT FURTHER RESOLVED that all members of the task force shall be registered voters in the State; and
8 9	BE IT FURTHER RESOLVED that the Office of Elections is
10	requested to convene the first meeting of the task force no
11 12	later than July 1, 2017; and
13 14	BE IT FURTHER RESOLVED that the Legislative Reference Bureau is requested to assist the task force as necessary; and
15 16	BE IT FURTHER RESOLVED that the task force is requested to
17 18	submit a report of its findings and recommendations, including proposed legislation, to the Legislature no later than twenty
19 20	days prior to the convening of the Regular Session of 2018; and
21 22	BE IT FURTHER RESOLVED that the task force and the Legislative Reference Bureau are requested to be available to
22 23	provide testimony to the Legislature and for informational
24 25	briefings; and
26 27 28	BE IT FURTHER RESOLVED that the task force shall cease to exist on the day of the adjournment of the Regular Session of 2018; and
