WHEREAS, various government and private nonprofit entities provide adult education services and opportunities for senior citizens on Oahu; and

WHEREAS, the members of the growing senior population benefit intellectually, socially, and physically from productive engagement in their community; and

WHEREAS, senior participation in free or low cost education courses often enhances diversity and perspectives in the learning experience for all students in these classes; and

WHEREAS, the quantity and quality of educational opportunities for adult and senior residents can benefit from a conscientious and thoughtful review of these programs; and

WHEREAS, these services often complement each other, but can sometimes be duplicative; and

WHEREAS, offering the same or similar services at multiple locations can be inefficient; and

WHEREAS, funding for the provision of services to seniors is limited; and

WHEREAS, coordinating and consolidating some University of Hawaii and Department of Education adult education opportunities and programs at selected locations and utilizing the savings to offer new learning opportunities may benefit seniors and be more economical; and
