JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO TRANSPORTATION.

PURPOSE: Extend the end date from June 30, 2017, to

June 30, 2022, that temporarily exempts
Department of Transportation and its

contractors from certain state requirements for certain bridge rehabilitation projects.

MEANS: Amend Act 218, Session Laws of Hawaii 2012,

sections 2 and 4 by extending the end date

from June 30 2017 to June 30, 2022.

JUSTIFICATION:

The Department of Transportation Highways Division is responsible for providing a safe, efficient, and effective land transportation system for the safe movement of people and goods. A critical and vital component of the land transportation system is the hundreds of bridges that span the many streams, rivers, and gulches across the islands. Because much of the islands' roadways were built decades ago on a belt system, many bridges were built to support the belt system and have become aged and obsolete. The belt system is vital to the economy of the islands and state as in many locations is the only route to, from and between communities as well as areas on opposite sides of the islands. The DOT however, has not been able to keep pace with the increasing need to upgrade and/or replace the aging bridges. The bridges will continue to deteriorate with time and as travel demands increase, and costs to reconstruct, replace, upgrade and maintain increase.

The purpose of Act 218 was to expedite construction of projects for the bridge rehabilitation and replacement program and provide temporary exemptions from certain state and county requirements. Act 218 became effective on July 1, 2012, and the exemption will expire on June 30, 2017, by

which time, construction of any bridge project using these temporary exemptions will need to be completed.

To make the most efficient use of state funding, the DOT leverages the federal aid highway program to finance the bridge rehabilitation and replacement program. As a condition to the federal aid funds, the DOT is required to comply with federal environmental regulations and requirements including the National Environmental Policy Act, section 106, section 7, and section 4(f), and is in addition to compliance with state and county environmental laws. These regulations are process oriented requirements and is time consuming.

The time extension of Act 218 will allow the DOT to continue moving forward with the listed bridge rehabilitation and replacement projects through completion of construction and provide for the most efficient manner to do so. Should the time extension not be approved, the DOT will be required to restart the design and environmental process for these projects to comply with state and county environmental regulations, which will delay the completion of construction.

Impact on the public: The extension of the bridges exemption will allow DOT to fully complete the construction and replacement of aging bridges from the various bridge rehabilitation projects and provide safer bridges for the driving public.

Impact on the department and other agencies: The extension will allow the DOT to continue moving forward with the listed bridge rehabilitation and replacement projects through completion of construction and provide for the most efficient manner to do so. In addition, the extension will prevent delays in construction schedules if the projects are not forced to start from the beginning if the extension is not granted.
