RELATING TO UNIVERSITY OF HAWAII RULEMAKING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that under the framework 2 established by chapter 91, Hawaii Revised Statutes, a state 3 agency is allowed to issue policy concerning its internal 4 management without having to follow various requirements for 5 adopting administrative rules, such as public notice, public 6 hearing, and gubernatorial approval. The legislature further 7 finds that the board of regents for the University of Hawaii 8 must conduct its business at an open meeting under the framework 9 established by chapter 92, Hawaii Revised Statutes. Currently, 10 there is a lack of consistency between the use of chapter 91 11 procedures and chapter 92 procedures for matters internal to the 12 University of Hawaii.

13 The purpose of this Act is to allow the board of regents 14 for the University of Hawaii to use the "open meeting" process 15 under chapter 92 rather than the "rule making" process under 16 chapter 91 for matters internal to the university. The public 17 will have opportunities to observe the board of regents and

9 All lands, buildings, appliances, and other property so 10 purchased or acquired shall be and remain the property of the 11 university to be used in perpetuity for the benefit of the 12 university. The board, in accordance with this section and 13 other law, shall manage the inventory, equipment, surplus 14 property, and expenditures of the university and [, subject to 15 chapter 91, may adopt rules, further] at an open public meeting 16 subject to the requirements of chapter 92 may adopt policy 17 controlling and regulating the same."

18 SECTION 3. Section 304A-402, Hawaii Revised Statutes, is 19 amended to read as follows:

"[+]§304A-402[+] Residence for tuition purposes[; basic
rule]. The board of regents shall adopt the necessary [rules]
policy at an open public meeting subject to the requirements of
chapter 92 defining residence for tuition purposes [herein];

JUSTIFICATION SHEET

DEPARTMENT: University of Hawaii

TITLE: A BILL FOR AN ACT RELATING TO UNIVERSITY OF HAWAII RULEMAKING.

PURPOSE: Allow the Board of Regents ("Board") for the University of Hawaii to regulate its internal operations under the "open meeting" process under the Sunshine Law under chapter 92, Hawaii Revised Statutes (HRS), rather than by the "rule making" process under chapter 91, HRS.

MEANS: Amend sections 304A-105(a), 304A-402, 304A-604, 304A-2160, and 304A-2601, HRS.

JUSTIFICATION: Under the framework established by chapter 91 concerning public "rules", a state agency is allowed to issue policies concerning its internal management without having to follow various requirements for adopting public rules, such as public notice, public hearing, and gubernatorial approval. Currently, there is a lack of consistency between the use of chapter 91 procedures and chapter 92 procedures in some sections of chapter 304A, HRS. This proposal continues to maintain the public's opportunity to observe and comment in an open meeting while meeting the chapter 92 open meeting requirement.

> For example, chapter 92 requires that the public be given advance notice when the Board intends to meet, that the public be given the opportunity to submit written or oral testimony on any item on the meeting agenda, that the Board deliberate and decide issues in an open meeting for public observation (except for those circumstances where an executive session closed to the public is permitted) and that the Board

maintain public written minutes of its meetings. Through chapter 92, the public is given ample opportunity to comment on proposed policies.

Impact on the public: None.

Impact on the department and other agencies: Authorizing the University to adopt policies pursuant to part I of chapter 92 will allow the University to create and update its internal management policies in a more timely and responsive manner while maintaining public transparency.
