A BILL FOR AN ACT

RELATING TO HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that an inability to
- 2 establish or corroborate the information required to establish a
- 3 person's identity poses many problems, especially for a person
- 4 who is homeless. Many shelters require identification so that
- 5 background checks may be conducted to ensure the safety of those
- 6 in the shelter. It often takes individuals several months to
- 7 obtain new identification and for a person who is homeless, a
- 8 lack of identification is a major obstacle in obtaining
- 9 government benefits and housing.
- 10 The purpose of this Act is to establish the housing for the
- 11 homeless special fund and executive office on homeless identity
- 12 protection to assist homeless individuals with the process,
- 13 including associated costs, of obtaining government-issued
- 14 identification documents.
- 15 SECTION 2. Chapter 346, Hawaii Revised Statutes, is
- 16 amended by adding two new sections to be appropriately
- 17 designated and to read as follows:



1	"8346-A Housing for the nomeless special rund;
2	established. (a) There is established in the state treasury
3	the housing for the homeless special fund, into which shall be
4	deposited any appropriations made by the legislature to the
5	fund.
6	(b) The moneys from the fund shall be expended by the
7	executive office on homeless identity protection to assist
8	homeless individuals with the process, including associated
9	costs, of obtaining government-issued identification documents.
10	(c) The department shall submit an expenditure report to
11	the legislature, no later than twenty days prior to the
12	convening of each regular session.
13	(d) The department shall adopt rules in accordance with
14	chapter 91 for the purposes of this section.
15	§346-B Executive office on homeless identity protection;
16	director; general functions, duties, and powers. (a) There is
17	established an executive office on homeless identity protection
18	that shall be temporarily placed within the office of the
19	governor; provided that on July 1, 2019, the executive office or
20	homeless identity protection shall be permanently established

3	(b)	The head of the executive office on homeless identity
4	protectio	n shall be known as the director of the executive
5	office on	homeless identity protection, hereinafter referred to
6	as the di	rector. The director shall:
7	(1)	Be appointed by the governor, notwithstanding section
8		26-34 and chapter 76;
9	(2)	Have professional training in the field of social work
10		or other related fields;
11	(3)	Have direct experience in programs or services related
12		to the homeless;
13	(4)	Have recent experience in a supervisory, consultative,
14		or administrative position;
15	(5)	Be paid a salary set by the governor that shall not
16		exceed ninety per cent of the salary of the director
17		of human resources development; and
18	(6)	Be included in any benefit program generally
19		applicable to the officers and employees of the State.
20	(c)	The director shall be responsible for:

1	(1)	Employing, supervising, and directing staff as may be
2		necessary for the purposes of this section;
3	(2)	Establishing policies and procedures governing the
4		operations of the office;
5	(3)	Administering funds allocated to the office and
6		applying for, receiving, and disbursing grants and
7		donations from all sources to assist homeless
8		individuals with the process, including associated
9		costs, of obtaining government-issued identification
10		documents; and
11	(4)	Assessing the policies and practices of other agencies
12		impacting the ability of homeless individuals to
13		obtain government-issued identification documents.
14	(d)	The office shall:
15	(1)	Assist homeless individuals with the process,
16		including associated costs, of obtaining government-
17		issued identification documents; and
18	(2)	Maintain records of requests for assistance and any
19		related documents."
20	SECT	ION 3. There is appropriated out of the general
21	revenues (of the State of Hawaii the sum of \$ or so

- 1 much thereof as may be necessary for fiscal year 2017-2018 and
- 2 the same sum or so much thereof as may be necessary for fiscal
- 3 year 2018-2019 to deposit to the credit of the housing for the
- 4 homeless special fund.
- 5 There is appropriated out of the housing for the homeless
- 6 special fund the sum of \$ or so much thereof as may be
- 7 necessary for fiscal year 2017-2018 and the same sum or so much
- 8 thereof as may be necessary for fiscal year 2018-2019 to
- 9 establish the executive office on homeless identity protection
- 10 for purposes of assisting homeless individuals with obtaining
- 11 government-issued identification documents.
- 12 The sums appropriated shall be expended by the executive
- 13 office on homeless identity protection for the purposes of this
- 14 Act.
- 15 SECTION 4. In codifying the new sections added by section
- 16 2 of this Act, the revisor of statutes shall substitute
- 17 appropriate section numbers for the letters used in designating
- 18 the new sections in this Act.
- 19 SECTION 5. New statutory material is underscored.

- 1 SECTION 6. This Act shall take effect upon its approval;
- 2 provided that section 3 shall take effect on July 1, 2017.
