A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE SEVENTH SENATORIAL DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The seventh senatorial district encompasses the
- 2 islands of Moloka'i, Lāna'i, and Kaho'olawe, as well as Hāna, east
- 3 and upcountry Maui all the way to Kahului Airport. This is one
- 4 of the "canoe" districts; as such, each island area has vastly
- 5 different capital improvement project needs.
- 6 The purpose of this Act is to appropriate funds for capital
- 7 improvement projects in the seventh senatorial district.
- 8 SECTION 2. The director of finance is authorized to issue
- 9 general obligation bonds in the sum of \$603,474,000 or so much
- 10 thereof as may be necessary, and the same sum or so much thereof
- 11 as may be necessary is appropriated for fiscal year 2017-2018
- 12 for the purpose of capital improvement projects for the seventh
- 13 senatorial district, as follows:
- 14 1. Kualapu'u Elementary School, Moloka'i
- 15 A. Replace roof.
- 16 Plans \$10,000
- 17 Design \$10,000
