### A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the tuition schedule 2 established by the board of regents of the University of Hawaii 3 has created an unreasonable increase in the cost of attendance. 4 For example, tuition fees for resident full-time undergraduate 5 students at the University of Hawaii Manoa has been steadily 6 increasing since academic year 2011-2012, by approximately 3.1 7 per cent in 2012-2013, 5.5 per cent in 2013-2014, 7.6 per cent 8 in 2014-2015, 5.1 per cent in 2015-2016, 5.1 per cent in 2016-9 2017, and tuition fees are scheduled to increase by another 1.9 10 per cent in 2018-2019.

11 The legislature recognizes that universities need funds to 12 operate, and that the University of Hawaii is trying to address 13 a substantial deferred repair and maintenance backlog. However, 14 the legislature finds that tuition costs at the university have 15 consistently and significantly been on the rise, even in recent 16 years, such as 2008-2010, in which the university has received

greater amounts of general fund appropriations from the
legislature.

3 The legislature finds that the cost of tuition at the 4 University of Hawaii is a matter of statewide concern and that 5 it is in the best interests of the State to ensure that all 6 students have affordable access to higher education.

7 Therefore, the purpose of this Act is to prohibit the board 8 of regents of the University of Hawaii from increasing tuition 9 fees until 2027, and require the university to provide the 10 legislature with an analysis of whether current tuition 11 increases are helping address the university's repair and 12 maintenance backlog.

13 SECTION 2. Section 304A-401, Hawaii Revised Statutes, is 14 amended by amending subsection (a) to read as follows: 15 "(a) The board of regents may charge resident and 16 nonresident tuition fees for regular courses of instruction at 17 any University of Hawaii campus, including any community 18 college [-]; provided that the board of regents shall not approve 19 any increase in regular credit or summer session tuition fees 20 until 2027."

1	SECTION 3. The University of Hawaii shall submit a report
2	to the legislature no later than twenty days before the
3	convening of the regular session of 2018 regarding the status of
4	the university's repair and maintenance costs and whether the
5	tuition increases effective through the 2019-2020 academic year
6	are assisting in addressing the repair and maintenance backlog.
7	SECTION 4. Statutory material to be repealed is bracketed
8	and stricken. New statutory material is underscored.
9	SECTION 5. This Act shall take effect upon its approval.
