A BILL FOR AN ACT

RELATING TO FERRY SYSTEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 268-1, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$268-1 Ferry system and facilities authorized. It being
- 4 hereby declared that the establishment of a ferry system to
- 5 provide the people of this State with an economic means of
- 6 transportation is a public purpose, the department of
- 7 transportation, hereinafter referred to as the department, [may]
- 8 shall acquire by lease, charter, contract, purchase,
- 9 condemnation, or construction, and partly by any or all of such
- 10 means, and thereafter operate, improve, and extend, as a public
- 11 undertaking and enterprise, a system of ferries between the
- 12 islands of the State and connecting with the public streets and
- 13 highways in the State, the system of ferries to include such
- 14 boats, vessels, wharves, docks, approaches, landings,
- 15 franchises, licenses, and appurtenances, as shall be determined
- 16 by the department to be necessary or desirable for the efficient
- 17 operation of a ferry system to best serve the public. In



- 1 general the department shall have all the powers necessary or
- 2 convenient to carry out effectively the purpose and provisions
- 3 of this chapter. The department may acquire by purchase,
- 4 condemnation, or construction and include in such ferry system
- 5 such approaches and connecting roadways as may be deemed by the
- 6 department advantageous in channeling traffic to points served
- 7 by the ferry system. The department may enter into any
- 8 contracts, agreements, or leases with any person, firm, or
- 9 corporation whether public or private and thereby provide, on
- 10 such terms and conditions as it shall determine, for the
- 11 operation of any ferry or ferries or system thereof, whether
- 12 acquired by the department or not. The department may further
- 13 exercise the power of eminent domain for the acquisition of
- 14 either real or personal property, necessary for the ferry
- 15 system. The department of land and natural resources shall
- 16 conduct any necessary environmental impact statements pursuant
- 17 to chapter 343 for an inter-island or intra-island ferry system
- 18 authorized by this chapter."
- 19 SECTION 2. Section 268-2.5, Hawaii Revised Statutes, is
- 20 amended to read as follows:

1	"[+]§268-2.5 Intra-island water ferry transportation
2	system; authority to implement.[] The department of
3	transportation [is authorized to] shall implement an intra-
4	island water ferry transportation system subject to chapter
5	103D. The intra-island water ferry transportation system shall
6	be premised upon the transportation of commuters during peak
7	traffic periods and may be used for other revenue-generating
8	purposes during non-peak traffic periods. The system may
9	include landings at various locations along the southern coast
10	of Oahu and shall be integrated with ground transportation.
11	The department of transportation and the department of land
12	and natural resources are authorized to:
13	(1) Waive or assess nominal fees for the use of public
14	infrastructures and terminals by the operator of the
15	intra-island water ferry transportation system; and
16	(2) Lease public lands at a nominal cost to the operator
17	of the intra-island water ferry transportation system.
18	In return for concessions as determined jointly by the
19	department of transportation and the department of land and
20	natural resources, the operator of the intra-island water ferry
21	transportation system shall provide the ferry service at no cost

- 1 or nominal cost to the State for the duration of the
- 2 concessions. Operating expenses may be further supplemented by
- 3 other revenue-generating activities during non-peak traffic
- 4 periods.
- 5 The department of transportation shall aggressively explore
- 6 the possibility of obtaining federal funds to implement the
- 7 intra-island water ferry transportation system."
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2017-2018 and
- 11 the same sum or so much thereof as may be necessary for fiscal
- 12 year 2018-2019 for costs associated with the implementation of
- 13 an inter-island or intra-island ferry system.
- 14 The sums appropriated shall be expended by the department
- 15 of transportation for the purposes of this Act.
- 16 SECTION 4. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 5. This Act shall take effect on July 1, 2017.
