A BILL FOR AN ACT

RELATING TO PAYMENT OF RENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 521-21, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$521-21 Rent. (a) The landlord and tenant may agree to
- 4 any consideration, not otherwise prohibited by law, as rent. In
- 5 the absence of such agreement, and subject to section 521-71(e)
- 6 in the case of holdover tenants, the tenant shall pay to the
- 7 landlord the fair rental value for the dwelling unit.
- 8 (b) Rents shall be payable at the time and place agreed to
- 9 by the parties. Unless otherwise agreed, the entire rent shall
- 10 be payable at the beginning of any term for one month or less,
- 11 and for longer terms in equal monthly installments payable at
- 12 the beginning of each month. When a rental agreement with a
- 13 public assistance recipient requires that the rent be paid on or
- 14 before the third day after the day on which the public
- 15 assistance check is usually received, the tenant shall have the
- 16 option of establishing a new due date by making a one-time
- 17 payment to cover the period between the original due date and
- 18 the newly established date. The new date shall not exceed by



- 1 more than three days, excluding Saturdays, Sundays, and
- 2 holidays, the date on which checks are mailed. The one-time
- 3 payment shall be established by dividing the monthly rental by
- 4 thirty and multiplying the result by the number of days between
- 5 the original and the new due dates.
- 6 (c) Except as otherwise provided in subsection (b), rent
- 7 shall be uniformly apportionable from day to day.
- 8 (d) When the tenancy is from month to month, the amount of
- 9 rent for such tenancy shall not be increased by the landlord
- 10 without written notice given forty-five consecutive days prior
- 11 to the effective date of the increase.
- 12 (e) When the tenancy is less than month to month, the
- 13 amount of rent for such tenancy shall not be increased by the
- 14 landlord without written notice given fifteen consecutive days
- 15 prior to the effective date of the increase.
- 16 (f) Where the rental agreement provides for a late charge
- 17 payable to the landlord for rent not paid when due, the late
- 18 charge shall not exceed eight per cent of the amount of rent
- 19 due."
- 20 SECTION 2. New statutory material is underscored.

- 1 SECTION 3. This Act shall take effect on November 1, 2017;
- 2 provided that section 1 of this Act shall apply to all rental
- 3 agreements entered into on or after the effective date of this
- 4 Act and all rental agreement renewals entered into on or after
- 5 the effective date of this Act.
