A BILL FOR AN ACT

RELATING TO PRIVATE TRADE, VOCATIONAL, AND TECHNICAL SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that private trade,
- 2 vocational, and technical schools provide specialized training
- 3 for a number of professions in the State, including those in
- 4 massage therapy, health care, tax preparation, and maritime
- 5 activities.
- 6 Currently, section 302A-425, Hawaii Revised Statutes,
- 7 prohibits such schools and other private organizations or
- 8 corporations for the purpose of teaching any trade, occupation,
- 9 or vocation from operating prior to being licensed by the
- 10 department of education. The department of education has had
- 11 this responsibility since 1939, when the focus of such
- 12 regulation was to ensure the quality of education and
- 13 instruction at those schools providing post-secondary training
- 14 below the college level.
- 15 The legislature finds that Act 57, Session Laws of Hawaii
- 16 1998, amended section 302A-425, Hawaii Revised Statutes, to
- 17 declare that the purpose of such regulation is to protect
- 18 consumers from false, deceptive, misleading, and unfair 2017-1380 SB1286 SD1 SMA.doc



- 1 practices, and to ensure adequate educational quality. The
- 2 legislature also finds that Auditor's Report No. 02-08, A Study
- 3 on the Licensing of Private Trade, Vocational, and Technical
- 4 Schools, acknowledged that the declaration of purpose added to
- 5 section 302A-425, Hawaii Revised Statutes, brought into question
- 6 the appropriateness of the program's administrative placement
- 7 within the department of education.
- 8 In 2015, the legislature passed S.C.R. No. 46, S.D. 2,
- 9 regular session of 2015, requesting the department of commerce
- 10 and consumer affairs and department of education to convene a
- 11 working group to evaluate and review the current licensing
- 12 program for private trade, vocational, and technical schools.
- 13 The working group jointly recommended that the licensure program
- 14 be narrowed in scope, but were unable to come to any other joint
- 15 recommendations.
- 16 The department of education's primary mission is
- 17 kindergarten to twelfth grade education, and does not include
- 18 the provision of post-secondary education or the regulation of
- 19 post-secondary institutions. The legislature finds that the
- 20 department of education does not currently have the capacity or
- 21 expertise in the specialized curricula of the various private

- 1 trade, vocational, and technical schools currently under its
- 2 licensing jurisdiction to effectively administer the
- 3 requirements of section 302A-425, Hawaii Revised Statutes.
- 4 Accordingly, the purpose of this Act is to clarify the
- 5 scope of the private trade, vocational, and technical school
- 6 licensure program; clarify the types of schools the department
- 7 of education is required to licensure; and establish a licensing
- 8 fee to ensure the program's sustainability.
- 9 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 10 amended by adding a new section to be appropriately designated
- 11 and to read as follows:
- 12 "\$302A- Private trade, vocational, and technical school
- 13 licensure special fund. There is created in the state treasury
- 14 a special fund to be designated as the private trade,
- 15 vocational, and technical school licensure special fund into
- 16 which shall be deposited:
- 17 (1) All revenues and fees collected by the department
- pursuant to section 302A-425; and
- 19 (2) Appropriations from the general fund of the State.
- 20 Moneys in the private trade, vocational, and technical school
- 21 licensure special fund shall be used to fund activities related

- 1 to the licensure requirements established under section 302A-
- 2 425, including funding for permanent staff positions and
- 3 administrative and operational costs."
- 4 SECTION 3. Section 302A-101, Hawaii Revised Statutes, is
- 5 amended as follows:
- 6 1. By amending the definition of "license" to read:
- 7 ""License" means the recognition granted by the Hawaii
- 8 teacher standards board to an individual to practice the
- 9 profession of teaching. This definition shall not apply to the
- 10 term "license" as it is used in [sections] section 302A-425 [to
- 11 302A-427]."
- 12
 2. By amending the definition of "private trade,
- 13 vocational, or technical school" to read:
- ""Private trade, vocational, or technical school" means
- 15 [any plan or method used by any person or persons, firm, or any
- 16 other] an organization or corporation [for giving] that provides
- 17 instruction in any form or manner in any trade, occupation, or
- 18 vocation for a consideration, reward, or promise of whatever
- 19 nature, [including correspondence schools located within the
- 20 State, except [as follows]:

SECTION 4. Section 302A-425, Hawaii Revised Statutes, is 1 2 amended to read as follows: "§302A-425 [License required for] Licensure of private 3 trade, vocational, or technical school. [No private trade, 4 vocational, or technical school shall be operated by any person 5 6 or persons, firm, or any other private organization or corporation for the purpose of teaching any trade, occupation, 7 8 or vocation unless there is first secured from the department a 9 license issued in accordance with sections 302A 424 to 302A 428 10 and in such form as the department may direct.] (a) The department shall license private trade, vocational, and 11 12 technical schools as necessary for compliance with federal 13 regulations and accreditation requirements. The purpose of the licensing and regulation is to protect consumers against 14 practices by private trade, vocational, or technical schools 15 that are false, deceptive, misleading, or unfair[, and to help 16 17 ensure adequate educational quality at private trade, vocational, or technical schools]. The department shall not be 18 19 responsible for review of curriculum or assurance of program quality for those private trade, vocational, and technical 20

1	(4)	A copy of the school's current general excise tax
2		license, including a current tax clearance; and
3	(5)	Proof that the school has secured a surety bond in the
4		sum of \$50,000, payable in a form satisfactory to the
5		department, to provide indemnification to any student
6		suffering a financial loss as a result of the school
7		not fulfilling its obligations under the terms of its
8		license; provided that the bonding requirement may be
9		reduced at the discretion of the department.
10	(c)	A private trade, vocational, or technical school
11	applying	for initial licensure shall pay an initial license fee
12	of \$	to the department upon application for licensure
13	under thi	s section.
14	(d)	Every two years following the date of initial
·15	licensure	, a private trade, vocational, or technical school
16	shall app	ly for a renewal license by:
17	(1)	Submitting all documents required under subsection
18		(b), with updated information as appropriate;
19	(2)	Submitting a list of complaints officially filed with
20		the department of commerce and consumer affairs

2	(e) Complaints alleging unfair or deceptive acts or			
3	practices by a private trade, vocational, or technical school			
4	shall be filed with the appropriate branch of the department of			
5	commerce and consumer affairs for review, investigation, and			
6	appropriate recommendation for action, including appeals from			
7	action taken.			
8	(f) Fees collected pursuant to this section shall be			
9	deposited into the private trade, vocational, and technical			
10	school licensure special fund.			
11	(g) The department may adopt reasonable rules relating to			
12	the enforcement of sections 302A-425 to 302A-426."			
13	SECTION 5. Section 302A-426, Hawaii Revised Statutes, is			
14	amended by amending subsection (a) to read as follows:			
15	"(a) The department, after notice and opportunity for a			
16	hearing, may suspend or revoke a license at any time when, in			
17	the judgment of the department, the licensee is not complying			
18	with [sections 302A-424 to 302A-428] section 302A-425 or the			
19	rules that may be adopted by the board. The notice of hearing			
20	shall be served personally or sent to the licensee by registere			

- 1 or certified mail with return receipt at the licensee's last
- 2 known address."
- 3 SECTION 6. Section 302A-424, Hawaii Revised Statutes, is
- 4 repealed.
- 5 ["[\$302A-424] Regulation of other schools and classes.
- 6 The department, at its discretion, may regulate schools,
- 7 classes, or courses excepted from the definition of "private
- 8 trade, vocational, or technical school"."]
- 9 SECTION 7. Section 302A-427, Hawaii Revised Statutes, is
- 10 repealed.
- 11 ["[\$302A-427] Powers of department. No license shall be
- 12 issued under sections 302A 424 to 302A 428 until the department
- 13 has approved the method and content of the advertising, the
- 14 standards and the methods of instruction, and the equipment
- 15 provided. The department may consult with trade or vocational
- 16 experts as to the equipment provided and the standards and
- 17 methods of instruction offered. The department may adopt
- 18 reasonable rules relating to the enforcement of sections 302A-
- 19 424 to 302A-428."]
- 20 SECTION 8. Section 302A-428, Hawaii Revised Statutes, is
- 21 repealed.

["[\$302A-428] Penalty. Any person, firm, or corporation 1 2 that violates sections 302A-424 to 302A-428 shall be guilty of a 3 misdemeanor, but shall be subject to a maximum fine of not more 4 than \$100 or imprisonment for not more than ninety days, or 5 both." 6 SECTION 9. All rules, policies, procedures, guidelines, 7 and other material adopted or developed by the department of education to implement sections 302A-424 to 302A-428, Hawaii 8 Revised Statutes, shall remain in full force and effect until 9 **10** amended or repealed pursuant to chapter 91, Hawaii Revised 11 Statutes. All licenses current as of the effective date of this **12** Act shall remain valid until the expiration of the licensure 13 term, at which point the private trade, vocational, or technical school shall be required to apply for initial licensure under 14 15 section 302A-425, Hawaii Revised Statutes. 16 SECTION 10. There is appropriated out of the general 17 revenues of the State of Hawaii the sum of \$ or so 18 much thereof as may be necessary for fiscal year 2017-2018 and 19 the same sum or so much thereof as may be necessary for fiscal 20 year 2018-2019 to be deposited into the private trade,

vocational, and technical school licensure special fund.

- 1 SECTION 11. There is appropriated out of the private
- 2 trade, vocational, and technical school licensure special fund
- 3 the sum of \$ or so much thereof as may be necessary
- 4 for fiscal year 2017-2018 and the same sum or so much thereof as
- 5 may be necessary for fiscal year 2018-2019 for administrative
- 6 costs associated with licensure of private trade, vocational, or
- 7 technical schools, including establishing one permanent full-
- 8 time equivalent (1.0 FTE) position within the department of
- 9 education.
- 10 The sums appropriated shall be expended by the department
- 11 of education for the purposes of this Act.
- 12 SECTION 12. Statutory material to be repealed is bracketed
- 13 and stricken. New statutory material is underscored.
- 14 SECTION 13. This Act shall take effect on July 1, 2050.
