### A BILL FOR AN ACT

RELATING TO WAHIAWA GENERAL HOSPITAL.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Wahiawa general
- 2 hospital is the only hospital that provides emergency medical
- 3 services in a vast geographical area, extending from Mililani to
- 4 Wahiawa, Waialua, Sunset, and Kahuku, which encompasses nearly
- 5 one-third of the island of Oahu.
- 6 Over the past ten years, Wahiawa general hospital has
- 7 experienced severe financial difficulties. To address these
- 8 circumstances, the hospital has cut programs, services, and
- 9 personnel, but these changes have not remedied the hospital's
- 10 financial deficit.
- 11 The legislature further finds that the optimal way to
- 12 decrease the hospital's financial deficit is to focus on
- 13 critical services that include emergency medical care, long term
- 14 care, and geriatric care. The Wahiawa center for community
- 15 health can assist patients who might lose services by the
- 16 downsize of Wahiawa general hospital. Although the hospital
- 17 will downsize, services will be available for the community of
- 18 Wahiawa.

10	SECTION 2. There is appropriated out of the general
11	revenues of the State of Hawaii the sum of \$ or so
12	much thereof as may be necessary for fiscal year 2017-2018 to
13	support basic operations, staff salaries and benefits, and
14	continued hospitalist physician services at Wahiawa general
15	hospital; provided that:
16	(1) Wahiawa general hospital shall discontinue acute care
17	services and focus only on emergency services, long
18	term care, and geriatric care; and
19	(2) The director of health shall negotiate with Wahiawa
20	general hospital for the terms of the release of funds
21	appropriated under this section.

1	The sum appropriated shall be expended by the department of
2	health for the purposes of this Act.
3	SECTION 3. The director of finance is authorized to issue
4	general obligations bonds in the sum of \$ or so much
5	thereof as may be necessary and the same sum or so much thereof
6	as may be necessary is appropriated for fiscal year 2017-2018
7	for the purpose of financing capital improvement projects for
8	Wahiawa general hospital; provided that:
9	(1) Wahiawa general hospital shall discontinue acute care
10	services and focus only on emergency services, long
11	term care, and geriatric care; and
12	(2) The director of health shall negotiate with Wahiawa
13	general hospital for the terms of the release of funds
14	appropriated under this section.
15	SECTION 4. The sums appropriated for the capital
16	improvement projects set forth in section 3 shall be expended by
17	the department of health for the purposes of this Act.
18	SECTION 5. The appropriation made for the capital
19	improvement projects authorized by this Act shall not lapse at

the end of the fiscal biennium for which the appropriation is

- 1 made; provided that all moneys from the appropriation
- 2 unencumbered as of June 30, 2020, shall lapse as of that date.
- 3 SECTION 6. This Act shall take effect on July 1, 2050.
