A BILL FOR AN ACT

RELATING TO SEPSIS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that sepsis is an
- 2 inflammatory response to a severe infection that can quickly
- 3 progress to multisystem organ failure and death. Early
- 4 recognition and intensive treatment are crucial to decreasing
- 5 morbidity and mortality from sepsis. However, sepsis is not a
- 6 reportable condition, and there is no single diagnostic test
- 7 that identifies cases of sepsis.
- 8 The legislature also finds that public education about
- 9 sepsis symptoms, diagnosis, treatment, and preventative measures
- 10 is lacking because sepsis is a clinical syndrome with many
- 11 causes that requires diagnosis by a clinician. Despite the lack
- 12 of public education about sepsis, groups such as the Centers for
- 13 Disease Control and Prevention and Sepsis Alliance work to
- 14 promote sepsis awareness. Currently, there is no organization
- 15 in Hawaii dedicated to provide education about, and raise
- 16 awareness of, sepsis.
- 17 Via the passing of house concurrent resolution no. 202,
- 18 S.D. 1 (2014), the legislature expressed its commitment to

- 1 support preventative measures to address the rising health
- 2 problem of sepsis and established the state sepsis task force.
- 3 Specifically, the resolution requested that the director of
- 4 health convene the task force to recommend ways to reduce
- 5 incidents of sepsis and sepsis deaths in the State, as well as
- 6 consider and incorporate the findings and recommendations of the
- 7 task force as feasible, as part of a comprehensive plan to be
- 8 developed by the department of health. In its January 2015
- 9 report to the legislature, the sepsis task force recommended the
- 10 adoption of sepsis educational materials and initiatives by
- 11 health care facilities.
- 12 Accordingly, the purpose of this Act is to establish a
- 13 pilot project to provide education about, and raise awareness
- 14 of, sepsis in Hawaii.
- 15 SECTION 2. (a) The department of health shall conduct a
- 16 one-year pilot project to provide education about, and raise
- 17 awareness of, sepsis across the State.
- (b) The pilot project shall:
- (1) Encourage the adoption of sepsis educational materials
- 20 and initiatives by health care facilities in the
- 21 State; and

1	(2) Disseminate current best practices to health care
2	facilities in the State regarding sepsis early
3	recognition and intervention.
4	(c) The department of health shall submit a report of its
5	findings and recommendations relating to the execution and
6	outcome of the pilot project, including any proposed
7	legislation, to the legislature no later than twenty days prior
8	to the convening of the regular session of 2018.
9	SECTION 3. There is appropriated out of the general
10	revenues of the State of Hawaii the sum of \$ or so
11	much thereof as may be necessary for fiscal year 2017-2018 for a
12	one-year pilot project to provide education about, and raise
13	awareness of, sepsis across the State.

The sum appropriated shall be expended by the department of
