A BILL FOR AN ACT

RELATING TO TUBERCULOSIS TESTING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to require the

2 department of health to accept Food and Drug Administration-

3 approved, Centers for Communicable Disease and Prevention-

4 recommended tests for tuberculosis infection in addition to the

5 Mantoux tuberculin skin test for the purpose of obtaining a

6 certificate of tuberculosis examination. Many people are

7 required to be tested for tuberculosis: children entering

8 school, school personnel, personnel working with higher-risk

9 populations, students enrolling in higher education programs,

10 and others. The addition of the Food and Drug Administration-

11 approved, Centers for Communicable Disease and Prevention-

12 recommended tests for tuberculosis infection as an approved

tuberculosis diagnostic is necessary because they are more

- 11 SECTION 3. Section 302A-1154, Hawaii Revised Statutes, is
- 12 amended by amending subsection (b) to read as follows:
- "(b) No child shall attend any school for the first time
- 14 in the State unless the child presents to the appropriate school
- 15 official documentation satisfactory to the department of health
- 16 that the child has been examined and tested according to the
- 17 rules of the department $[\tau]$ and law and is free from tuberculosis
- 18 in a communicable form."
- 19 SECTION 4. The department of health shall amend its
- 20 administrative rules to reflect the addition of a Food and Drug
- 21 Administration-approved, Centers for Communicable Disease and

- SECTION 5. Any existing administrative rules and 5

Report Title:

Tuberculosis Testing (TB); Department of Education; Department of Health; Certificate of TB Examination

Description:

Requires the department of health to accept FDA-approved, CDC-recommended tuberculosis (TB) blood tests in addition to the TB skin test for the purpose of obtaining a certificate of TB examination. Amends the law requiring tuberculosis clearance prior to public school entry to be in accordance with law in addition to department of health rules. Clarifies that the department of health's administrative rules regarding the use of the Mantoux tuberculin skin test or chest x-rays in obtaining a certificate of tuberculosis examination shall remain in effect until amended to include the addition of TB blood tests as an acceptable TB diagnostic.
