A BILL FOR AN ACT

RELATING TO VOTING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
- 2 by adding two new sections to part II to be appropriately
- 3 designated and to read as follows:
- 4 "§11-A Applications for a driver's license or civil
- 5 <u>identification card.</u> (a) Notwithstanding any law to the
- 6 contrary, an affidavit on application for voter registration
- 7 shall be a part of the application associated with the issuance
- 8 of a civil identification card under section 286-301 and
- 9 driver's license under section 286-109; provided that the
- 10 affidavit meets the requirements of section 11-15(a).
- 11 (b) Applications for a civil identification card or
- 12 driver's license shall not be processed until the applicant
- 13 clearly indicates on the application that the applicant is
- 14 declining to register to vote or the portion of the application
- 15 related to voter registration is completed.
- 16 §11-B Electronic accessibility of voter registration
- 17 applications associated with the examiner of drivers. (a) The



- 1 examiner of drivers of each county shall ensure that the
- 2 contents of the affidavit on application for voter registration
- 3 provided by applicants in conjunction with their driver's
- 4 license and civil identification card application are
- 5 electronically stored in a database of each county examiner of
- 6 drivers.
- 7 (b) The examiner of drivers in each county shall
- 8 electronically provide to the respective county clerk the voter
- 9 registration information set forth in the affidavit on
- 10 application for voter registration. This information shall
- 11 include a digital copy of the applicant's signature.
- 12 (c) Upon receipt of the electronic information, the county
- 13 clerk shall treat the information as constituting an application
- 14 to register under section 11-15.
- 15 (d) Databases maintained by the counties and the state
- 16 department of transportation containing driver's license and
- 17 civil identification card information shall be electronically
- 18 accessible by the statewide voter registration system to allow
- 19 for the timely processing of voter registration applications
- 20 made in conjunction with driver's license and civil
- 21 identification cards, facilitate verification of information

Section 286-109, Hawaii Revised Statutes, is amended to read as follows: 5 6 "§286-109 General provision governing the issuance of 7 licenses. (a) Upon payment of the required fee and upon 8 demonstrating the ability to operate a certain category or 9 categories of motor vehicles to the satisfaction of the examiner 10 of drivers, an applicant for a driver's license shall be issued 11 a single license of a design approved by the director of 12 transportation upon which is made a notation of: 13 (1) The category or categories of motor vehicles the 14 applicant may operate;

17 (3) Veteran status, if desired by the applicant; provided
18 that the notation shall be on the front of the license
19 and shall not include any designation other than the

- 8 served in any of the uniformed services of the United States,
- 9 including veterans of the Korean conflict and persons who served
- 10 in the armed forces of the Republic of Korea, who fought under
- 11 the command of the United Nations led by the United States,
- 12 during the Korean conflict and are currently United States
- 13 citizens, and was discharged under conditions other than
- 14 dishonorable.
- 15 (b) The examiner of drivers shall not issue or renew any
- 16 driver's license using the driver's social security number on
- 17 the driver's license.
- 18 (c) Statutes of limitations and other provisions of this
- 19 chapter notwithstanding, no driver's license or instruction
- 20 permit shall be issued or renewed under this section, where the
- 21 examiner of drivers is notified by the district judge, traffic

violations bureaus of the district courts, or the judge of the 2 circuit court that the applicant has failed to respond to a 3 traffic citation or summons, or failed to appear in court after 4 an arrest for the violation of any traffic laws of a county, 5 this chapter or chapter 286G, 287, 290, 291, or 291C, or of any 6 motor vehicle insurance laws under article 10C of chapter 431, 7 or of any motorcycle or motor scooter insurance laws under 8 article 10G of chapter 431, and the same remains delinquent and 9 outstanding, or the applicant, has as of the time of the 10 application, failed to comply in full with all orders of the 11 court; provided that the district court with whose order an 12 applicant has failed to comply in full, may approve the issuance or renewal of a driver's license or instruction permit other 13 14 than a commercial driver's license upon conditions imposed by 15 the court for the satisfaction of the outstanding court order **16** and any other conditions as may be imposed by the court, if one or more of the following conditions are met: 17 18 (1)The applicant is gainfully employed in a position that 19 requires driving and will be discharged if the

applicant is unable to drive; or

1 (2) The applicant has no access to alternative 2 transportation and therefore must drive to work; 3 provided further that if the applicant has failed to comply in 4 full with orders of the district court of more than one circuit, 5 the applicant shall obtain the approval of the district court of 6 each circuit in which the applicant has an outstanding court 7 order before a driver's license or instruction permit may be 8 issued or renewed under this subsection. 9 A driver's license or instruction permit issued or renewed 10 under this subsection shall be subject to immediate suspension 11 by the court upon the applicant's failure to remain in full 12 compliance with all conditions imposed by the court for the 13 issuance or renewal of the driver's license or instruction 14 The examiner of drivers may place an indication of 15 restriction upon a driver's license or instruction permit issued 16 or renewed under this subsection. Proof of financial **17** responsibility under section 287-20 shall not apply to the 18 issuance or renewal of driver's licenses or instruction permits 19 under this subsection. 20 (d) An application for a driver's license shall include

the information required under section 11-A."

- 1 SECTION 3. Section 286-301, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+] §286-301[+] Issuance of identification card or
- 4 temporary card. (a) To obtain an identification card from the
- 5 examiner of drivers, an individual shall complete an application
- 6 pursuant to section 286-303.
- 7 (b) The examiner of drivers, upon receipt of the
- 8 application by any individual who is a resident or a temporary
- 9 resident of this State, shall issue an identification card to
- 10 that individual upon receipt of any appropriate fee established
- 11 pursuant to section 286-309.
- 12 (c) The identification card shall be similar in size,
- 13 shape, and design to a driver's license, but shall not entitle
- 14 the individual to whom it is issued to operate a motor vehicle.
- 15 (d) The issuance of an identification card pursuant to
- 16 this section shall not place upon the State of Hawaii or any
- 17 agency any liability for the misuse or the acceptance of the
- 18 identification card as valid identification, which shall be left
- 19 entirely to the discretion of any individual to whom such card
- 20 is presented.

1 (e) An application for an identification card from the 2 examiner of drivers shall include the information required under 3 section 11-A." 4 SECTION 4. Section 286-311, Hawaii Revised Statutes, is 5 amended by amending subsection (a) to read as follows: 6 "(a) [All] Except for purposes of voter registration 7 information in sections 286-109 and 286-301, information and 8 records acquired by the examiner of drivers under this part 9 shall be confidential. All information and records shall be 10 maintained in an appropriate form and in an appropriate office 11 in the custody and under the control of the examiner. The 12 information shall be available only to authorized individuals under such restrictions as the director shall prescribe. 13 14 examiner may dispose of any application or identification card, 15 or information or record relating to the application or 16 identification card, which does not include a social security number, without regard to chapter 94, whenever, in the **17** 18 examiner's discretion, retention of the information or record is 19 no longer required or practicable." 20 SECTION 5. In codifying the new sections added by section 21 1 of this Act, the revisor of statutes shall substitute

Voter Registration; Driver's License; Civil Identification Card

Description:

Specifies that an affidavit on application for voter registration shall be a part of the application associated with the issuance of a civil identification card and driver's license. Requires each county examiner of drivers to electronically store the contents of the affidavit on application for voter registration provided by applicants in conjunction with their driver's license and civil identification card applications and provide electronic accessibility of this information. Effective 1/1/2018.
