A BILL FOR AN ACT

RELATING TO DENTAL HYGIENISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that dental hygienists
- 2 are highly-trained, important members of an oral health team who
- 3 administer a range of oral health services to patients.
- 4 However, under current law, licensed dental hygienists must
- 5 operate under the direct supervision of a licensed dentist in
- 6 most circumstances, meaning a supervising licensed dentist must
- 7 examine and diagnose the condition to be treated, authorize each
- 8 procedure, and remain in the office or facility while the
- 9 procedure is being performed.
- 10 The legislature further finds that when a dental hygienist
- 11 operates under general supervision, the supervising licensed
- 12 dentist must still examine and diagnose a condition to be
- 13 treated and authorize each procedure to be carried out, but the
- 14 supervising licensed dentist is not required to be physically
- 15 present during the delegated act or procedure. Under general
- 16 supervision, the dentist must still be available for
- 17 consultation even if not physically present during the delegated



- 1 act or procedure and is still responsible for all delegated acts
- 2 and procedures performed by licensed dental hygienists.
- 3 Permitting licensed dental hygienists to operate under general
- 4 supervision, rather than direct supervision, will give dentists
- 5 more flexibility in their practices and enable the dentistry
- 6 profession to keep pace with increased patient need, while still
- 7 maintaining certain safeguards for patients.
- 8 Accordingly, the purpose of this Act is to permit licensed
- 9 dental hygienists in the State to operate under general
- 10 supervision of a licensed dentist.
- 11 SECTION 2. Section 447-1, Hawaii Revised Statutes, is
- 12 amended by amending subsection (f) to read as follows:
- "(f) No person shall practice dental hygiene, either
- 14 gratuitously or for pay, or shall offer or attempt so to
- 15 practice, or shall advertise or announce publicly or privately
- 16 as being prepared or qualified so to practice without having a
- 17 license as provided in this section. The original or a copy of
- 18 the certificate of licensure shall be prominently displayed at
- 19 all times in the workplace where the dental hygienist is
- 20 employed or practices. A dental hygienist's pocket
- 21 identification card shall be readily available for viewing upon



- 1 request to ensure the license is current. A licensed dental
- 2 hygienist shall practice only under the supervision of a
- 3 licensed dentist as provided in this chapter; provided that a
- 4 licensed dental hygienist shall administer under the [direct]
- 5 general supervision of a licensed dentist only those categories
- 6 of intra-oral block anesthesia listed in the course content
- 7 submitted to the board pursuant to subsection (a)."
- 8 SECTION 3. Section 447-3, Hawaii Revised Statutes, is
- 9 amended by amending subsections (b), (c), and (d) to read as
- 10 follows:
- "(b) Clinical dental hygiene may be practiced by a
- 12 licensed dental hygienist. The practice of clinical dental
- 13 hygiene is defined as the removal of hard and soft deposits and
- 14 stains from the portion of the crown and root surfaces to the
- 15 depth of the gingival sulcus, polishing natural and restored
- 16 surfaces of teeth, the application of preventive chemical agents
- 17 to the coronal surfaces of teeth, which chemical agents have
- 18 been approved by the board of dental examiners, and the use of
- 19 mouth washes approved by the board, but shall not include the
- 20 performing of any repair work or the preparation thereof, or any
- 21 other operation on the teeth or tissues of the mouth; provided

- 1 that nothing in this subsection shall prohibit a dental
- 2 hygienist from using or applying topically any chemical agent
- 3 which has been approved in writing by the department of health
- 4 for any of the purposes set forth in part V of chapter 321, and
- 5 other procedures delegated by a dentist in accordance with the
- 6 rules of the board of dental examiners.
- 7 In addition, a licensed dental hygienist may administer
- 8 intra-oral infiltration local anesthesia and intra-oral block
- 9 anesthesia under the [direct] general supervision of a dentist
- 10 after being certified by the board, and for those categories of
- 11 intra-oral infiltration local anesthesia and intra-oral block
- 12 anesthesia for which the licensed dental hygienist has been
- 13 certified through a course of study meeting the requirements of
- 14 this chapter.
- 15 (c) A licensed dental hygienist may operate in the office
- 16 of any licensed dentist, or legally incorporated eleemosynary
- 17 dental dispensary or infirmary, private school, welfare center,
- 18 hospital, nursing home, adult day care center or assisted living
- 19 facility, mental institution, nonprofit health clinic, or in any
- 20 building owned or occupied by the State or any county, but only
- 21 under the aforesaid employment and under the [direct or] general

- 1 supervision of a licensed dentist[; provided that in the private
- 2 practice of dentistry, the hygienist shall be under the direct
- 3 supervision of a licensed dentist]. No dental hygienist may
- 4 establish or operate any separate care facility which
- 5 exclusively renders dental hygiene services.
- 6 (d) A licensed dental hygienist may operate under the
- 7 general [or direct] supervision of any licensed dentist
- 8 providing dental services in a public health setting. As used
- 9 in this subsection, "public health setting" includes dental
- 10 services in a legally incorporated eleemosynary dental
- 11 dispensary or infirmary, private school, welfare center,
- 12 hospital, nursing home, adult day care center or assisted living
- 13 facility, mental institution, nonprofit health clinic, or the
- 14 State or any county. A licensed dental hygienist employed in a
- 15 public health setting may perform dental education, dental
- 16 screenings, and fluoride applications. Other permissible duties
- 17 shall be pre-screened and authorized by a supervising licensed
- 18 dentist, subject to the dentist's determination that the
- 19 equipment and facilities are appropriate and satisfactory to
- 20 carry out the recommended treatment plan. No direct
- 21 reimbursements shall be provided to licensed dental hygienists."
