A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a thorough education
- 2 must incorporate opportunities for children to think critically
- 3 and question received assumptions. By nurturing children's
- 4 innate sense of wonder and curiosity, and initiating open-ended
- 5 discussion and inquiry, educators can foster students to engage
- 6 in the type of reflective and critical thinking that will allow
- 7 them to flourish as responsible citizens in a complex and
- 8 changing world.
- 9 In addition, the legislature finds that bullying,
- 10 cýberbullying, peer aggression, violent behavior, and harassment
- 11 pose a serious concern for our children and that the teaching of
- 12 critical thinking, conflict resolution, compassion, empathy,
- 13 social-emotional learning, and collaboration is addressed by the
- 14 Philosophy for Children program, or P4C, at the University of
- 15 Hawaii's Uehiro Academy for Philosophy and Ethics in Education,
- 16 which has been shown to lead to the prevention of peer

- 1 aggression in and out of school in those schools in which the
- 2 program has been incorporated.
- 3 The legislature further finds that the P4C program offers a
- 4 workable model to introduce philosophical inquiry into Hawaii's
- 5 public schools by providing teachers with the tools necessary to
- 6 help their students develop complex problem solving, critical
- 7 thinking skills, and sound judgment and reasoning. This program
- 8 received legislative funding in the 1980s, which enabled
- 9 teachers of the department of education to train in the program
- 10 at the University of Hawaii and then share their skills with
- 11 other teachers in the school and complex.
- 12 Accordingly, the purpose of this Act is to support the
- 13 integration of philosophical education in public schools by
- 14 making appropriations to fund the P4C program and to allow a
- 15 small number of teachers of the department of education the time
- 16 to train in the program.
- 17 SECTION 2. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$ or so much
- 19 thereof as may be necessary for fiscal year 2017-2018 and the
- 20 same sum or so much thereof as may be necessary for fiscal year

- 3 The sums appropriated shall be expended by the University
- 4 of Hawaii for the purposes of this Act.
- 5 SECTION 3. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so much
- 7 thereof as may be necessary for fiscal year 2017-2018 and the
- 8 same sum or so much thereof as may be necessary for fiscal year
- 9 2018-2019 to allow teachers of the department of education to
- 10 train with the P4C program of the University of Hawaii Uehiro
- 11 Academy for Philosophy and Ethics in Education.
- 12 The sums appropriated shall be expended by the department
- 13 of education for the purposes of this Act.

14 SECTION 4. This Act shall take effect on July 1, 2017.
