A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE ALZHEIMER'S DISEASE AND RELATED DEMENTIA SERVICES COORDINATOR POSITION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii 2025:
- 2 State Plan Alzheimer's Disease and Related Dementias, published
- 3 by the executive office on aging, identifies goals and key
- 4 strategies to improve the lives of the numerous families
- 5 affected by the disease. The legislature further finds that
- 6 Alzheimer's disease is the sixth leading cause of death in the
- 7 United States and that it affects twenty-seven thousand Hawaii
- 8 residents, a number that will increase by more than forty per
- 9 cent by the year 2025. The legislature also finds that an
- 10 estimated sixty-five thousand unpaid caregivers in this State
- 11 provide seventy-four million hours of unpaid care each year.
- 12 With the significantly high number of individuals affected
- 13 by Alzheimer's disease as a person having the disease or as a
- 14 caregiver, and the substantial projected increase by 2025, there
- 15 is a need for a coordinated and prepared support system to
- 16 address the multitude of issues arising from addressing the
- 17 disease. While the Hawaii 2025: State Plan Alzheimer's Disease

- 1 and Related Dementias identifies strategies to address the
- 2 disease, the services and activities require coordination at a
- 3 systemic level, such as through a coordinator position.
- 4 The purpose of this Act is to make an appropriation for an
- 5 Alzheimer's disease and related dementia services coordinator
- 6 position.
- 7 SECTION 2. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so
- 9 much thereof as may be necessary for fiscal year 2017-2018 and
- 10 the same sum or so much thereof as may be necessary for fiscal
- 11 year 2018-2019 for the establishment of one full-time equivalent
- 12 (1.0 FTE) Alzheimer's disease and related dementia services
- 13 coordinator position, exempt from chapter 76, Hawaii Revised
- 14 Statutes, within the executive office on aging.
- 15 The sums appropriated shall be expended by the department
- 16 of health for the purposes of this Act.
- 17 SECTION 3. This Act shall take effect on July 1, 2017.
