A BILL FOR AN ACT

RELATING TO ANIMALS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that every year over one									
2	hundred million animals are used as subjects of scientific and									
3	medical research, as well as for educational purposes. As									
4	recently as 2015, over 19,000 cats and 61,000 dogs were used in									
5	research. The legislature further finds that many of the									
6	animals used for research and education are euthanized after									
7	they are used, despite being healthy and suitable for adoption									
8	The purpose of this Act is to:									
9	(1) Require research facilities to make available for									
10	adoption healthy cats and dogs that are no longer									
11	required for research; and									
12	(2) Allow research facilities to contract with local									
13	animal shelters and rescue groups to facilitate the									
14	adoptions.									
15	SECTION 2. Chapter 143, Hawaii Revised Statutes, is									
16	amended by adding a new section to be appropriately designated									
17	and to read as follows:

1	" <u>§143-</u> <u>Animal research</u> . (a) A research facility, or									
2	employee or student thereof, that confines cats or dogs for									
3	science, education, or research purposes and plans to euthanize									
4	a cat or dog for purposes other than science, education, or									
5	research shall first offer the cat or dog to an animal rescue									
6	organization for adoption if the animal is suitable for adoption									
7	and the research facility's existing procedures for adopting the									
8	animal do not result in an adoption. A research facility that									
9	is required to offer cats or dogs to an animal rescue									
10	organization under this section may enter into an agreement with									
11	an animal rescue organization for the implementation of this									
12	section.									
13	(b) A research facility that provides a cat or dog to an									
14	animal rescue organization under this section is immune from any									
15	civil liability that otherwise might result from its actions;									
16	provided that the research facility is acting in good faith.									
17	(c) For the purposes of this section:									
18	"Animal rescue organization" means any nonprofit									
19	organization established for the purposes of rescuing animals in									
20	need and finding permanent, adoptive homes for the animals.
