A BILL FOR AN ACT

RELATING TO THE MITIGATION OF HAZARDOUS SITUATIONS STATEWIDE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 127A-18, Hawaii Revised Statutes,
- 2 authorizes the Governor to designate state employees, agents,
- 3 contractors, or representatives, when no emergency exists, to
- 4 enter private property at reasonable times to mitigate
- 5 situations deemed by the Governor to be hazardous to the health
- 6 and safety of the public. The landowner and occupier are given
- 7 notice and a reasonable opportunity to mitigate the hazardous
- 8 situation without assistance of the State. If state assistance
- 9 is required, the State may seek recovery and reimbursement of
- 10 costs and expenses.
- 11 This program has proven to be very effective in mitigating
- 12 hazards within the State. As of November 30, 2016, a total of
- 13 598 cases were received, of which 474 were resolved and closed.
- 14 The majority of these closed cases resulted from outreach and
- 15 mediation efforts by the Hawaii Emergency Management Agency
- 16 between the complainant and property owner. During the 2016
- 17 Tropical Storm Darby event, minimal damage was reported by the

- 1 counties from downed Albizia trees and other hazards. This is
- 2 in sharp contrast to the major damage to highways, power lines,
- 3 and homes caused by downed Albizia trees on the island of Hawaii
- 4 during Tropical Storm Iselle in 2014. This improvement was due
- 5 largely to the mitigation of hazardous situations program and
- 6 other culling projects conducted by the counties and other
- 7 organizations.
- 8 Funding for this program in the amount of \$1,000,000 was
- 9 appropriated by Act 122, Session Laws of Hawaii 2014. This
- 10 funding will lapse on June 30, 2017. As of November 30, 2016,
- 11 approximately \$300,000 of the funding has been obligated with
- 12 \$700,000 remaining. The purpose of this Act is to extend the
- 13 lapse date to June 30, 2019 to allow these remaining funds to be
- 14 available for the program.
- 15 SECTION 2. Act 134, Session Laws of Hawaii 2013, as
- 16 amended by Act 122, Session Laws of Hawaii 2014, is amended by
- 17 amending section 26.1 to read as follows:
- 18 "SECTION 26.1. Provided that of the general fund
- 19 appropriation for amelioration of physical disaster (DEF 110),
- 20 the sum of \$1,000,000 or so much thereof as may be necessary for
- 21 fiscal year 2014-2015 shall be expended for the purpose of

- 1 mitigating hazardous situations statewide in accordance with
- 2 section [128-10.3] 127A-18, Hawaii Revised Statutes; provided
- 3 further that any funds not expended for this purpose shall not
- 4 lapse to the general fund at the end of the fiscal year
- 5 appropriated but shall be carried forward into subsequent years;
- 6 and provided further that any unexpended funds shall lapse to
- 7 the general fund on June 30, [2017] 2019."
- 8 SECTION 3. Statutory material to be repealed is bracketed
- 9 and stricken. New statutory material is underscored.
- 10 SECTION 4. This Act shall take effect on June 29, 2017.
