## A BILL FOR AN ACT

RELATING TO THE STATE BUILDING CODES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. For centuries, Hawaii has been blessed with
- 2 consistent rainfall and, due to its geology, with high-quality
- 3 fresh water. Recently, however, scientists, farmers, and others
- 4 have observed signs that threaten the long-term fresh water
- 5 security of the Hawaiian islands.
- 6 The Pacific Islands Regional Climate Assessment reports
- 7 that throughout the Pacific region, warmer and drier conditions
- 8 will result in drought and rising temperatures, thus causing a
- 9 decrease of fresh water supplies.
- 10 Hawaii needs to make changes that will increase its ability
- 11 to capture, store, and efficiently use fresh water. Among the
- 12 least expensive and most efficient ways to increase the supply
- 13 of fresh water are water conservation and reuse. An important
- 14 component in the conservation and reuse of water is the timely
- 15 adoption, through amendments to the state building codes, of
- 16 changes to the model Uniform Plumbing Code that encourage water
- 17 resource conservation, improvements to water distribution
- 18 systems, and recovery of used water.



- The purpose of this Act is to expedite the review,
  updating, and adoption of appropriate updates to the Uniform
- 3 Plumbing Code, through amendments to the state building codes.
- 4 SECTION 2. Section 107-24, Hawaii Revised Statutes, is
- 5 amended by amending subsection (f) to read as follows:
- 6 "(f) The council shall review and adopt, as appropriate,
- 7 new model building codes within eighteen months of the official
- 8 publication date [-]; provided that the council shall review and
- 9 adopt the necessary and desirable amendments to the Uniform
- 10 Plumbing Code within one year after the updated Uniform Plumbing
- 11 Code is published by the International Association of Plumbing
- 12 and Mechanical Officials."
- 13 SECTION 3. Section 107-28, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "\$107-28 County authority to amend and adopt the Hawaii
- 16 state building codes without council approval. (a) The
- 17 governing body of each county shall amend, adopt, and update the
- 18 Hawaii state building codes as they apply within their
- 19 respective jurisdiction, in accordance with section 46-1.5(13),
- 20 without approval of the council. Each county shall amend and
- 21 adopt the Hawaii state building codes and standards listed in

- 1 section 107-25, as the referenced Hawaii state building codes
- 2 and standards for its respective county building code ordinance,
- 3 no later than two years after the adoption of the Hawaii state
- 4 building codes[-]; provided that each county shall adopt the
- 5 necessary and desirable amendments to the Uniform Plumbing Code
- 6 specified in section 107-25(2) within one year after the updated
- 7 Uniform Plumbing Code is adopted by the council.
- 8 (b) If a county does not amend the Hawaii state building
- 9 codes within the [two-year] time frame [two-year] specified in
- 10 subsection (a), the Hawaii state building codes shall become
- 11 applicable as an interim county building code."
- 12 SECTION 4. Statutory material to be repealed is bracketed
- 13 and stricken. New statutory material is underscored.
- 14 SECTION 5. This Act shall take effect on July 1, 2017.
