A BILL FOR AN ACT

RELATING TO MARINE LIFE CONSERVATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the health of SECTION 1. 2 Hawaii's marine ecosystem is a matter of serious and ongoing concern in the State. In particular, coral in Hawaii's waters 3 4 have shown increasingly significant signs of damage, including 5 extensive bleaching. The legislature further finds that many factors, such as water temperature, contribute to this damage, 6 but that the damage is exacerbated by the presence of chemicals 7 8 that are toxic to coral.

9 The legislature additionally finds that recent research has demonstrated that oxybenzone is toxic to coral organisms, causes 10 11 deformation in the larval form of coral, and contributes to coral bleaching. The legislature also finds that oxybenzone is 12 13 a chemical blocker that protects skin from ultraviolet radiation. As a result, oxybenzone is commonly found in 14 sunscreens and other similar personal care products. Oxybenzone 15 16 can be released into the ocean when a swimmer who has applied sunscreen enters the water, or through the waste mist plume of 17

1	spray-on sunscreen. The legislature further finds that elevated
2	levels of oxybenzone have been detected at popular swimming
3	beaches throughout the State, including Waimea bay and Waikiki
4	beach on Oahu, and Honolua bay on Maui.
5	The purpose of this Act is to prohibit the use or
6	application of sunscreen and sunblock containing oxybenzone
7	while in a marine life conservation district.
8	SECTION 2. Chapter 190, Hawaii Revised Statutes, is
9	amended by adding a new section to be appropriately designated
10	and to read as follows:
11	" <u>§190-</u> Oxybenzone; sunscreen and cosmetics
12	restrictions. No person while in a marine life conservation
13	district shall use or apply sunscreen or sunblock containing
14	oxybenzone or any cosmetic with sunscreen containing oxybenzone.
15	For purposes of this section, "oxybenzone" includes
16	benzophenone-3 and 2-hydroxy-4-methoxyphenyl phenylmethanone."
17	SECTION 3. New statutory material is underscored.
18	SECTION 4. This Act shall take effect upon its approval.
